Council President Murphy vacated the chair for the purpose of discussing Papers 350 and 351-23; Councillor-At-Large Spadafora served as Acting Council President. Discussion began with Councillor Murphy presenting an outline of changes that were made in this version of the Council Rule Book, which include consent agenda, remote access to meetings, utilizing Committee of the Whole more effectively, constitutionality of public comment, adding the option for President Pro Tempore, improved code of conduct, basic editing for clarity.

After lengthy debate, five motions for amendments were made then the amendments on the whole of the book were voted. Paper will come back on the next Council agenda for a final vote to put the 2023 Rule Book into effect.
