Councillor Winslow, the sponsor of the paper said that the paper will address the permitting process with the Recreational Department. If people in the parks are not following the rules there is no enforcement, the paper would allow the Parks and Recreation Department to fine abusers and clarify the permits that are issued by the Parks and Recreation Department would be good for one year and anything above that would need to be approved by the City Council.
