Chair Crowe turned it over to the sponsor of the paper Councillor Winslow.

Councillor Winslow told the committee that Trafton has been having some issues with kids being in the Trafton dog park with no dogs which is a requirement for being of the dog park. There is also an issue of the hours the dog park is open. Councillor Winslow wants to have signs made for the hours of the dog park and before the signs are made the hours need to be firmed up. Councillor Winslow would like the Stadium and Athletic Commission to establish the hours. Councillor Sica made a motion to amend the paper to strikeout the hours and add the hours be established by the Stadium and Athletic Commission.

A motion was made by Councillor Sica, seconded by Council President Spadafora that the Ordinance be recommended favorably as amended to the City Council. The motion carried by a unanimous vote.

Chair Crowe asked the sponsor, Councillor Winslow to speak on the paper. Councillor Winslow told the committee he has had conversations with Recreational Director Joe Levine and Laura Perez regarding the permitting process of using the parks. Councillor Winslow continued as of now there is nothing to make people apply for permits. Councillor Winslow gave an example of the Mystic Valley Charter School who are in wards 2, 6 and 7. In ward 6, the school is always using Trafton Park and it could be all day long where no permit is issued. Councillor Winslow said that Trafton Park, Kierstead Park in ward 7 and Devir Park in ward 2 are having expensive upgrades that are going to take place and those groups that use the park will need to help pay for the maintenance of the park and even have their hours cut back that they use the park so regulations need to be put in place. Councillor Winslow said the Athletic and Stadium Commission can issue permits for any term less than a year but anything over a year would have to be issued by the Council. Councillor Winslow further stated that there are guidelines only if someone has applied for a permit and that permit is issued and that we need to clarify the ordinance, you can't have someone using the fields all day long. Councillor Winslow stated that the city has always given exclusive agreements to the Charter School but that is being deferential to the Charter School. They are using a loophole now so they aren't applying for permits. Councillor Winslow said the Commission is 75% there what needs to be done and he would like the Council to figure out the last 25%. Councillor Winslow said his motivation is to have clear rules and people using the fields there is an extra cost.

Councillor Sica stated that she is not against the paper and wants to make sure the committee gets it right. Councillor Sica suggested having Recreation Director Levine in before the committee and made a motion to table and bring in Mr. Levine.

Council President Spadafora suggested we look at Cambridge rules that they use for fields.

A motion was made by Councillor Sica, seconded by Council President Spadafora that the Ordinance be tabled to the Rules & Ordinance Committee and have Director Levine come before the Committee. The motion carried by a
