Boston Gas dba Nationalgrid, hereby respectfully requests your consent to the locations of mains as hereinafter described for the transmission and distribution of gas in and under the following public streets, lanes, highways and places of the **City of Malden** and for the pipes, valves, governors, manholes and other structures, fixtures and appurtenances designed or intended to protect or operate said mains and accomplish the objects of said Company; and the digging up and opening the ground to lay or place same:

To install and maintain a brand new 6-inch prefabricated district regulator station with approximately 100 ft of 8-inch inlet gas main and approximately 80 feet of 12-inch outlet gas main in Charles street, (abutting Stop and Shop) near the intersection of Canal Street. In addition to the station a stainless-steel control box and three vent poles shall also be installed .
