Councillor McDonald opened discussion by stating the Council is still in the early stages of fully understanding the history of Malden in its relationship with the original indigenous residents of the area. Land acknowledgements are becoming common in other cities and public bodies. The Community Engagement Committee took up this subject at a recent meeting but did not have a lot of attendance. Nevertheless, Councillor McDonald would like to see the Council adopt this as a permanent part of the weekly agenda, but would additionally like to find substantial ways to uphold the voices of Malden's indigenous

people in real time.

Councillor McDonald suggested reviewing Massachusetts Indigenous Legislative Agenda for a starting point of action items that would be a meaningful demonstration of support.

Councillor O'Malley agrees that more community engagement is necessary over and above the CEIC, possibly even a public hearing. He expressed he has received comments from people who said the land acknowledgement tends to sound performative. Councillor O'Malley suggested, for example, looking up local landmarks and streets to learn their original names and hanging signs to acknowledge that history, as a way to make the land acknowledgement be something more than performative.

Councillor McDonald noted the land acknowledgement is no more or less performative than the tribute we give to service members at the beginning of every Council meeting. The land acknowledgement is only one step, not meant to be the only nor the final action. They further noted their view that there is a difference between a performative activity and a ceremonial ritual acknowledgement.

Councillor O'Malley moved to table until the CEIC can do further community engagement in terms of what does the Community think we should be doing when it comes to honoring Native Americans?

A motion was made by Councillor O'Malley, seconded by Councillor Crowe, that the Order be tabled. The motion carried by a unanimous vote.

Order: That Section 5.00 NON-MEMBERS' RIGHT TO FLOOR, subsection 5.04 of the 2023 City Council Rule Book be amended by inserting the following:

- In the last sentence, after 'name': ", street and city or"

Be it further amended that subsection 5.05 of the 2023 City Council Rule Book be amended by inserting the following:

- After 'name': ", street and city or"
- After the first sentence "Upon request, the City Clerk may privately verify a speaker's address in lieu of it being part of the legislative record."

Final Paper 29-25 City Council Rule Book - 5.04 and 5.05 Non-members Rights to Floor

This paper is in direct response to multiple requests received by Councillor McDonald around people's discomfort with publishing their personal residence as part of the permanent Council record. For those who are concerned about their safety but still wish to participate can have their addresses verified in advance through the Clerk's office.

Clerk Desiderio commented that everybody who lives in the City of Malden, unless they are a public safety official, has their names and address as a part of the public record already, that information is not held as private per state law. The original point of having people sign in with name and address on the record was to show our residents have skin in the game when they come before their council. Years ago when having the discussion to add Public Comment to the Council agenda part of the debate revolved around, people have to identify themselves. To clarify, the language of Paper 29-25 doesn't say the person speaking at Public Comment gets to remain anonymous, but rather they must speak their name and street OR address.

A motion was made to amend the paper to indicate the commenter may identify themselves by stating their name and street and city or address. As well as amending public record to read legislative record.

A motion was made by Councillor Taylor, seconded by Councillor O'Malley, that the Order be amended. The motion carried by a unanimous vote.

A motion was made by Councillor O'Malley, seconded by Councillor Taylor, that the Order be recommended favorably as amended to the City Council. The motion carried by a unanimous vote.

30-25 Order: That Section 34.00 (RESERVED) of the 2023 City Council Rule Book be

amended by renaming the section 'PHRASING OF MOTIONS'

Be it further amended by adding a new subsection 34.01 by inserting the following: "All motions regarding actions of the City Council must be phrased as positive relative to the status quo and may not be phrased in the negative. This section shall not prevent the Council from enacting any order in its power."
