Discussion on this paper opened with Councillor Colon-Hayes stating that it has been a couple months since the last update given by Legal to the full Council on the Benevolent Botanicals court case and she feels it is a good idea to get updated.

Councillor later went on to say that she has the right to call for ES whenever she wants and without accusation of conflict of interest. And in fact, she is concerned with anyone who doesn't want to enter into ES and that seems "sketchy".

Councillor Sica is not in support of this Executive Session as the City Solicitor will request through Council President if/when updates are needed and since that hasn't happened, this doesn't seem necessary. She further stated that she is concerned there may be a conflict of interest regarding Councillor Colon-Hayes' relationship to the parties in this case.

Councillor O'Malley expressed support of getting more frequent updates on all open cases in general, suggesting perhaps quarterly reports would be a good idea. Councillor Winslow agreed that the Council would be well served with more frequent updates from Legal then went on to read Massachusetts Ethics Code for Lawyers, Rule of Professional Conduct, Rule 1.4: Communication. He later stated that he has not been consulted as to what the City's objectives are in this lawsuit. He is not sure the Council has a specific objective and would like the opportunity to understand the strengths of their defense.

Councillor Crowe agreed that she would like more frequent updates in generally but for this specific case, asked to bring City Solicitor John McNaught Jr. to the podium to ask if there is any substantial updates that would require this evening's ES. Solicitor McNaught replied there has been no change in the case with the exception of the adversary's letter to the full administration demanding a settlement, which cannot be done as the ordinance in question has not changed so what they are asking for cannot be provided. Councillor Condon is comfortable with hearing Solicitor McNaught state there has been no changes so does not see a need to enter ES.

A motion was made by Councillor at Large McDonald, seconded by Councillor O'Malley, that the Order be adopted. The motion failed by the following vote:

According to the MSPCA Angell Animal Hospital, "Second Generation Anticoagulant Rodenticides (SGARs) are a type of poison used for rodent control that work by stopping the blood clotting processes, causing lethal hemorrhage. SGARs have been extensively used for rodent control, allowing secondary exposure and poisonings in non-target wildlife species, such as birds of prey that mainly feed on rodents or small birds. SGARs are prohibited for residential consumer purchase in the Commonwealth, but commercial use is allowed for licensed pesticide companies when hired to deal

with rodent problems."
