#### Minutes to be Approved

326-23

Order: That the City Council accept the provisions of M.G.L. c. 203C, the Massachusetts Prudent Investor Act, and adopt the local option allowing Municipal Treasurers to apply the Prudent Investor Rule to optimize returns on trust fund monies.

### **Sponsors:** Carey McDonald

The committee had a discussion on Paper #326-23- Prudent Investment Act. Prior to the Governor's most recent budget it would take a vote of the City Council and a petition to the legislature for approval, with the passing and this being included in the Governor's budget it only takes the local adoption of MGLc203C. Dan explained in order to institute the Prudent Investment Rule where the state allows the City to adopt this act and allows the City to invest trust funds in a broader variety of assets outside of the current state restrictive lists. This would allow the trust funds more access to a larger variety of investment options to generate more income. The committee voted to table this paper and invite Dan back to a future Finance Committee Meeting once he obtains pending information requested regarding Paper #326-23.

A motion was made by Councillor Condon, seconded by Councillor at Large Colon Hayes, that the Order be tabled to the Finance Committee. The motion carried by a unanimous vote.
