Massachusetts Electric Company d/b/a National Grid and Verizon New England, Inc requests permission to locate poles, wires, and fixtures, including the necessary sustaining and protecting fixtures, along and across the following public way:

Lebanon St - National Grid to install 1 JO Pole on Lebanon St beginning at a point approximately 66 feet southwest of the centerline of the intersection of Hartshorn St and Lebanon St and continuing approximately 31 feet in a southwest direction. Installing new Pole 2426, ~31' southwest of existing P2427 on Lebanon St.
