Councillor Winslow introduced Paper 343-25, proposing that the City Council develop a home rule petition to regulate private ways within the city. The proposal aims to address issues such as parking and public access, particularly in areas where commercial businesses and residential houses coexist.

The proposal was discussed in the context of Ivan Street, a private way with both residential houses and commercial businesses. The tension arises from the use of the street by business patrons, leading to conflicts with residents. Under current state law, private way residents can post signs and tow vehicles, but this approach has been contentious and inconsistent.

Councillor Winslow mentioned consulting the Fire Chief, who confirmed that there are no significant public access issues on Ivan Street, as it is a short street. The Chief was not concerned about fire hydrant access since there's no hydrant on the street.

Councillor Winslow highlighted the lack of city authority to regulate private ways, which hampers efforts to expand residential-only parking. This home rule petition would seek to grant the city the authority to regulate these areas, allowing for more consistent and fair management. He emphasized the importance of gathering feedback from residents and conducting community outreach to ensure the proposal addresses their concerns and needs effectively.

Councillors Crowe and Condon mentioned past attempts to regulate private ways have faced obstacles, including the need for unanimous consent from all abutting property owners. This requirement has often stalled progress and prevented effective regulation.

Councillor O'Malley discussed the need to work with the Legal Department to develop appropriate language for the petition. This step is crucial to ensure that any new regulations are legally sound and enforceable. He also considered the financial implications of taking on additional responsibilities for regulating private ways. He noted that the city would need to assess the costs and benefits of such regulations to ensure they are financially sustainable.

Councillor Taylor wondered how many unaccepted street there are in Malden. She would like to continue to look into developing this home rule petition but would like to know what areas would be affected.

Councillors Winslow and O'Malley suggested the paper be tabled for the Legal Department to do research on the requirements for converting a private way to a public way and the what legal authorities the city has over private ways and come back with their findings.

A motion was made by Councillor O'Malley, seconded by Councillor Crowe, that the Order be tabled. The motion carried by a unanimous vote.
