Discussion opened with Councillor McDonald introducing CFO Chuck Ranaghan and asking for a brief history of Paper 7-23 and it's relevance to paper 8-23 to be voted by the Finance Committee in conjunction with this meeting. CFO Ranaghan explained Paper 7-23 is to update the salary schedule in the MCC to reflect changes agreed to during union negotiations with Library staff. The numbers reflected in the chart include contractual 2.5% cost of living adjustments as of July 2021 and going into 2022 and 2023. This chart includes all Library staff including those who are not currently in the union.
