Keenan Brinn, 100 Apollo Drive, Chelmsford appeared before the Council representing ExteNet Systems. The purpose of this petition is to seek a grant of location to install 4-inch fiber conduit in the public right of way from the intersection of Main Street & Madison around the corner to Charles Street, approximately 650'. Plans are attached to the history of Paper 214-23.

Councillor Crowe stated this piece of road has recently been paved and so on the recommendation of DPW and Engineering Department, condition of this petition is that the streets and sidewalks be restored to the satisfaction of the Director of Public Works including mill and pave the entire intersection from curb to curb, no zipper patch, and including line striping.

Councillor Winslow observed the plans for this project are based on old information that do not include the Northern Strand and this also crosses a MBTA right of way. He made a motion to table until ExteNet Systems can come back with up to date, less confusing plans that also account for special cross walks that were put in during the past year.

Councillor Spadafora inquired what the fiber conduit is for, exactly. What came from this line of questioning is that the fiber underground eventually sets this company up to put up 5G antennas on poles in the future. With this, Councillor Spadafora seconded Councillor Winslow's motion to table because this issue goes back to the double/triple pole issue the City is currently having with utility companies. He further stated he is not in support of any more 5G cells in the city; this petition feels like bait and switch.

Council President Murphy continued with the public hearing. Christopher Dreher of 166 Mountain Avenue was the only person to speak on this petition; he spoke in opposition.

A motion was made by Councillor Winslow, seconded by Councillor at Large Spadafora that the Petition be tabled to the City Council pending the petitioner providing updated engineering plans showing the Northern Strand. The motion carried by a unanimous vote.

Be it ordained by the City Council of the City of Malden that the Code of the City of Malden (MCC) is hereby amended by adding Title 9, Chapter .08, Section 030 REMOVAL OF LITTER AT ENTRANCES

Every person or business that holds a license to sell tobacco or nicotine delivery products from the City of Malden Board of Health shall, at its own expense, provide, place, and regularly maintain a cigarette litter receptacle at any public entrance and employee smoking areas, and shall weekly sweep up litter associated with tobacco and nicotine delivery products such as cigarette butts and packaging from any sidewalk abutting such business. Violations of this section may be punished by agents of the Board of Health and the Public Works Department in the manner provided in M.G.L. c. 40 § 21D according to the punishment schedule set forth in Section 6.12.040.

Residents may bring their e-waste for free to the bin at the DPW on Commercial Street. This vendor showed up at the Green Malden Fair this spring held at Pine Banks Park.

Resolve: Whereas: Many of the areas along Eastern Avenue and the Northern Strand Community Trail have industrial zoning put in place during the time the Saugus Branch Railroad continued to exist:

Whereas: Industrial Zoning has lead to a proliferation of storage buildings and other uses that do not take advantage of the potential this corridor has to serve surrounding neighborhoods and trail users;

Whereas: The lack of greenery both within the public right-of-way along Eastern Avenue and abutting private land is unattractive and contributes to heat island effect that exists along this area, and

Whereas: Communities in the Boston region and across the country have re-imagined the areas abutting rail trails to become dynamic urban spaces through trail-orientated development.

Therefore: The Malden City Council hereby resolves and requests that the City of Malden through its Office of Strategic Planning and Community Development pursue grants and technical assistance with the intent to update zoning along this Corridor through a collaborative public process.

OSPCD Roosevelt finance presentation April 25 2023

Councillor McDonald introduced this paper by first speaking about the process. Three meetings of the Finance Committee were held for Papers 139 and 140-23; meetings were held in person and by Zoom webinar. A lot of good information was shared but Paper 139-23 was ultimately sent back to the Full Council without recommendation. That was due in part because the Full Council needs to weigh in on the issue of turf at Roosevelt Park but also because a majority of members of the subcommittee wished to review what a full grass-based option cost estimate would look like. Councillor McDonald wanted to see if there was support from the Body for such an order.

Councillor Simonelli stated that he has heard enough of the discussion of Roosevelt Park and wished to move Paper 139 to vote.

Councillor Colon-Hayes wished to thank members of the public who have come out to speak on this paper. She is not in support of anything less than real grass at Roosevelt Park. She still wishes to see the cost comparison on real grass as well as the Board of Health decision on PFAS at the park prior to moving this to vote.

Councillor O'Malley explained, for the sake of the public, that the pro-grass advocates do not have the votes needed for this paper. This doesn't mean they are in favor of turf or have given up on the option of moving to grass at some point in the future but to see that happen will require some level of compromise with the administration.

Councillor Winslow read from a written statement explaining the history of the project and his position on this issue, which remains with turf and to say he is still in support of Paper 139 and 140.

Councillor Condon commented an 8–10-year lifespan on a turf field is a falsehood when properly maintained, as is evidenced by Macdonald Stadium and South Broadway Park. If Roosevelt Park doesn't last, it will be the fault of the City for not taking proper measures with maintenance of the turf but doesn't see that happening.

Councillor McDonald acknowledges that Roosevelt clearly needs help but hoped there was another option available on which to vote. He is concerned with the long-term impacts of turf on the environment; grass is also not the most environmentally responsible option; there are always going to be trade offs and there are valid opinions on both sides of this issue.

From the Chair, Council President Murphy pointed out one thing that Councillor Winslow left out of his closing, that the city did speak to the students, families, facility of Salemwood School, community members, etc. Many conversations were had and from those discussions, compromises and updates were made to the plans for the park.

A motion was made by Councillor Simonelli, seconded by Councillor Sica, that the Order be adopted. The motion carried by the following vote:
