A motion was made by Councillor D'Arcangelo, seconded by Councillor Murphy, that the Council adopt the ground rules of eliminating the candidate with the least amount of votes in the first round of voting for the Treasurer/CFO. The motion carried by the following vote:

**Yea:** 7 - Anderson, Condon, D'Arcangelo, Matheson, Murphy, Sica and Spadafora

**Nay:** 3 - DeMaria, O'Malley and Crowe

**A motion was made by Councillor Murphy, seconded by Councillor D'Arcangelo, to close nominations. The motion carried by a unanimous vote.**

**Daniel Grover was eliminated as a candidate, having had the least amount of votes this round.**
