A motion was made by Councillor Linehan, seconded by Councillor Winslow, that the Ordinance be taken from the table to the Rules & Ordinance Committee. The motion carried by a unanimous vote.

In a previous Rules and Ordinance meeting, Paper 198-23 had been tabled until City Planner Michelle Romero was able to be in attendance. Councillor Winslow wanted to hear from her on the reasons why the Planning Board would have made a recommendation to deny this zoning change, especially since it has the support of six co-sponsors.

Planner Romero explained that at the July 17, 2023 Planning Board meeting seven of the nine members voted to recommend disapproval of this amendment. Currently, self-storage facility use is only used in Industrial 1 and 2 districts in the city. This use is allowed by special permit and the PB is of the belief that the special permit regulations are adequate. Storage facilities are viable business models that need to be some place in the city, they typically have low traffic impact, add to the City's tax base, and have no impact to neighborhoods. The amendment is not supported by any known substantive planning objectives, community need or general welfare.

Councillor Winslow inquired if there is a way to compromise by splitting the paper wherein they aren't totally prohibited city-wide but rather down specific roadways? It was explained that if the Council was concerned with self storage facilities being allowed, they could propose to become the special permit granting authority of self storage facilities again so the Council would then have control over the regulations. It terms of splitting the district, the Council could do that but they would have to come up with legal descriptions and boundaries of what that would look like. Another alternative would be to allow them in Industrial 2 and not in Industrial 1. Some of these options would require a new paper and begin the process over again.

Councillor Winslow preferred to vote this paper out favorably in spite of the Planning Board's recommendation.

A motion was made by Councillor Winslow, seconded by Councillor Linehan, that the Ordinance be recommended favorably to the City Council. The motion carried by a 4-1 vote.
