Business

Chair Councillor Murphy gave an overview of the Renewal process this year for Dealers licenses. Because of the changes incorporated this year with renewal applications there have been some issues especially with certified plot plans and the ones submitted have had the wrong parking space dimensions for Dealer Licenses. The required dimension of 10x20 have not been followed with the plans instead the plans are using 9x18 as the dimension. Building Commissioner Miller has reviewed all plot plans submitted and has not been able to sign off on any. Councillor Murphy wanted to keep the process moving and not deny anyone that has submitted all the required documents for the renewal application. Councillor Murphy suggested licenses could be granted with the stipulation that the required certified plot plan be submitted and approved by May 1st. Councillor Anderson reminded the committee that when issuing a license it would indicate for the entire 2020 year. Compliance Officer Morse stated to the committee that compliance would not be able to do their job if plot plans were not submitted and approved. Discussion took place that grandfathered licenses showing 0 cars should be exempt from having to provide a plot plan. Councillor Condon made a motion to strike the plot plan requirement from any license that has 0 cars, Councillor Anderson seconded the

motion, motion carried 4-0. Councillor Anderson made a motion to refer to Ordinance that Licenses with 0 cars not be required to have a dealer plate, Councillor Condon seconded the motion, motion carried 4-0. Councillor Condon made a motion, Councillor Anderson seconded that all completed applications will be recommended out of committee favorably with the stipulation that the Licensee have until May 1, 2020 to submit a certified plot plan to be approved by the Building Commissioner and Fire Department, motion carried 4-0. Councillor Linehan made a motion that any License that is able to provide the missing information up until when the Committee Report is voted on the floor this night will be included with the Licenses that will be granted in committee, Councillor Anderson seconded the motion, motion carried 4-0. Councillor Condon left at 6:00 to attend the Parking Review Committee meeting. Councillor Anderson moved that Licenses with no application submitted and still doing business should be contacted by Compliance and be issued a Warning within 48 hours and be fined after 7 days, Councillor Linehan seconded, it was so voted 3-0. Councillor Anderson moved that applications that are incomplete will not be reviewed until completed and will be contacted, after 14 days fines will be issued, seconded by Councillor Linehan and it was so voted 3-0.
