# Initial Formation

## OSCPD created coinciding with the FY22 budget

- Integrated off-street parking management with the City parking department
- Repurposed prior MRA agency into City department focused on community, business and economic development

## With nearly two years under our belt, time to evaluate and tweak

- Set up the organization for future success
- Address new areas of focus and strengthen existing efforts & initiatives
- Recognize the demand on staffing resources required to succeed in multiple focus areas

# What Has Changed

# Funding Supports the Mission Community Development

#### Lead & Healthy Homes Grant Awarded August, 2021

- Focus on lead-safe housing
- \$3,100,000; end date May 2025
- 10% allowed for admin costs and management
- Competitive grant

#### Healthy Homes Grant Awarded March 2022

- Focus on hazard reduction to ensure healthy homes
- \$1.7 million; end date 2025
- 10% allowed for admin costs and management
- Competitive Grant

#### MassSave Grant Awarded December, 2021

- Focus is on energy efficiency in homes and businesses
- \$60k for three years (performance based)
- Required to hire a PT Energy Advocate

#### Energy Efficiency and Conservation Block Grant

 Developing sustainable green building guidelines for housing rehab programs

## Funding Supports the Mission Housing Support

#### Funding Secured Since Formation

- ARPA HOME Program Awarded September 2021
  - Focus is on homelessness and homelessness prevention
  - \$7.3 million; end date 2030
  - Malden is the lead for 8 communities through the North Suburban Consortium
  - 15% administrative fee maximum; approved by NSC as part of budget
- Annual HOME award approximates \$2.16M
- OSPCD also manages Affordable Housing Trust Fund; sits as staff on the City's ARPA Subcommittee on Housing; provides assistance to non-profit developers in the affordable housing field and funds a rehab and healthy homes program for income eligible owners


