A public hearing was held wherein Attorney Roberto DeMarco spoke on behalf of DMS Trinity Naturals, as did Timothy Halpin.

There were two letters read into the record against the petition. One was from Brian DeLacey and the other RE Centers representing Stop & Shop stating they will not allow Trinity customers to park in their lot.

Attorney DeMarco explained the need for the amendment to this special permit is due to an error caused by the job's contractor. His entire presentation may be viewed at the 26:19 mark in the above noted Teams video link. He apologized for the discrepancy and further stated DMS is not contesting any of the 20 recommendations as presented by the Planning Board. The amendment to the special permit will not increase the amount of people expected to frequent the business. It is only to increase the size of the back vault. The hope is the business will open by springtime and they have an agreement with New England Coffee to use parking as well as a plan to purchase two-hour parking permits for CBD Garage as to not impede on the Stop & Shop parking lot. Further, DMS is working with the City and the abutting property owner to connect the Spot Pond Greenway Project to the bike path, per recommendation number 18 from the Planning Board's report. Councillor O'Malley circulated a hand out with an amended version of number 18, which is attached to the history of Paper 77-25.

Councillor Crowe stated she needs further information about the handout for proposed condition #18, as it was not previously discussed with her, the Ward Councillor. She is prepared to vote in support of the petition but not on proposed condition #18.

Councillor Colon Hayes thanked the petitioners for admitting their mistake with the contractor but she's having a hard time supporting this without public hearings; the letter from Stop & Shop makes it sound like some of their abutters aren't happy. Attorney DeMarco mentioned Market Basket in Chelsea as an example of how they are able to

work with neighbors. He stated his disappointment in the public comment read this evening for its incorrect information. Further he stated DMS has had more public meetings than any applicant in any city that he has seen so far. DMS has sent mailings to the community and held seven public meetings, which only saw a total of five participants in attendance. Attorney DeMarco also clarified the ownership of this company has not changed. The company does have a team of investors, who have been properly disclosed, but those investors do not have an ownership stake. Council President O'Malley asked a member of Cannabis Licensing and Enforcement Commission to confirm this information. Ronald Hogan spoke to that point on behalf of CLEC.

Petraq Xheka of 117 Medford Street, Malden spoke as a representative of National Grid in support of this petition. No one spoke in opposition during the public hearing portion of the discussion. The entire discussion may be viewed at the 59:15 minute mark of the above noted Teams video link.

National Grid wishes to install a joint-owned 50' pole with Verizon at 1944-50 Eastern Avenue in between poles 1944 and 1945 to relieve some of the load from one of the other poles that is also being replaced. The sponsoring ward Councillor, Simonelli, waved option to speak on this petition.

Councillor Spadafora asked for further clarification of why National Grid requires an additional pole at this particular location and if anything else was going on the pole, will it be leased out? A disconnect switch and three phase transformer. Councillor Spadafora asked for a condition that they replace the sidewalk to the satisfaction of the DPW Director and that the pole in not used for equipment from any other company besides National Grid. ie: no wi-fi antennas. He stated there are times when a company will put up a pole with an alternative reason just to get around the ordinance disallowing poles just for wi-fi antennas. Councillor Spadafora also asked if National Grid can utilize an on the ground pad transformer, eliminating the need for so many buckets and poles.

Councillor O'Malley pointed out there is already a double pole at this location, only three poles away, having multiple transformer buckets. He asked if Mr. Xheka could bring information back to the Body on taking down the double pole and to meet with the Ward Councillor on site for further review of this plan and pending conditions.

Public Comment Paper 80-25 O. Schwab

This paper was introduced as a way to open further discussion in increasing affordable housing in response to the recent law changes revolved around housing with MBTA zoning and the by-right accessory housing units.

Councillor Spadafora explained that the Malden Court House was obtained by the City of Malden in August of 2022 with restrictions by the previous Governor on selling the building. He believes if the current Governor was approached with a proposal to sell the court house for the purpose of affordable housing, it would now be allowed. The building needs at least \$19m to bring it up to code for the purpose of using it as an arts center but the city doesn't have the funds to see this through to fruition. Malden is having a similar funding issue with the Oak Grove Community Building.

There is significant Council and community support for keeping both of these building for their intended purposes. Councillor Linehan acknowledges the Affordable Housing Trust Fund Action Plan identifies that surplus property should be on the table for discussion but also asked for an amendment to strike mention of these two buildings from the paper so that discussion may revolve around only affordable housing. She further stated her continued believe in the future of a successful arts center in the old courthouse. Councillor Simonelli spoke about the stage area in the temple site in Ward Seven, when he was originally hoping to use it for the arts and was told it couldn't be done. The entire building is now being used for affordable housing.

Councillor McDonald stated he is happy to introduce a similar resolve to incentive building of more affordable housing. They agree with opening discussion of surplus properties, prioritizing properties that are without current plans for future use. They also believe the city should allow changes to zoning ordinances that will allow people to more easily build affordable housing. Other cities incentivize this and so too should Malden.
