Chair Spadafora stated the changes submitted in paper 267-21 are for the upcoming FY22 Budget. Councillor Winslow wanted discussion on the COO title, wanted to know more about the role and COO is a vanilla title and may not describe what Mr. Hogan actually does. There was discussion the title should be changed from COO to Chief of Strategy & Innovation Officer. Councillor Winslow made a motion to add section 2.20.03 to the Revised Ordinances of 2020 and change the title to Chief Strategy & Innovation Officer.
