## **Business**

512-22Order: That the sum of Twenty-Two Thousand Five Hundred Dollars (\$22,500) is<br/>appropriated from available general fund free cash and transferred to Board of Health<br/>Recovery Coaches, account number 0010-510-5103

#### Sponsors: Barbara Murphy

Councillor Murphy said although this money is in free cash it actually came out of an Opioid Settlement the City recieved. One of the ways we would like to utilize this money is to hire a full-time recovery coach. There is a part-time position already and this money will merge with the existing money which has been funded already to create a full-time position. Dan said the funds from the Opioid Settlement were not able to be deposited to a

revolving fund so they are deposited as General Fund Revenue from the DOR which is why they ended up in Free Cash. the amount of \$22,500 represents half a year salary

since there is only half the fiscal year left.

Councillor Murphy said with the Board of Health there is a tremendous outreach in the community and the amount of people they are helping is incredible. Our overdoses and fatals are down significantly from last year.

Paul said he has been doing this job since 2017. He is the Addiction Recovery Resource Specialist. It has been so busy and City Hall closes at 5:00 on Thursday and he has been working every weekend as the calls don't stop. It has been nights and weekends for the past five years and he needs and assistant. This new position if granted would cover weekends and nights. Malden Cares is a big part of what he does right now and it is funded by ARPA. He is at the warming center till 10:00 at night and it's seven nights a week. It would be a huge help to the City and beneficial to him. Councillor Colon-Hayes asked if this position is a new hire full-time or if there is someone already working? She also said ARPA is funding Malden Cares so who oversees Malden Cares?

Paul said there are 10 recovery coaches currently working not under the City Budget they are funded by ARPA. He oversees Malden Cares through the Board of Health. It is a collaboration between Malden Overcoming Addiction and the City of Malden. The funds are run through the City and he answers to Chris Webb, BOH Director, Anthony Chiccuarelli, HR Director, Chuck Ranaghan, CFO and Dan Grover, Treasurer.

A motion was made by Councillor Sica, seconded by Councillor at Large Colon Hayes, that the Order be recommended favorably to the City Council. The motion carried by a unanimous vote.

513-22 Order: That the sum of One Million Two Hundred Thousand Dollars (\$1,200,000) is appropriated from available water sewer enterprise fund retained earnings and transferred to Water Sewer Capital, account number 6010-450-5860

#### Sponsors: Barbara Murphy

Dan explained Mike Neville is the new supervisor in the Water Department has done an analysis of what his needs are. This money would be used to fund a vactor truck, a sewer jet, a valve turning truck, a dump truck and two pick-up trucks the money would come from Water Sewer retainer earnings. Based on his recommendations he found these trucks would be a real value to the Water Department.

A motion was made by Councillor Sica, seconded by Councillor Condon, that the Order be recommended favorably to the City Council. The motion carried by a unanimous vote.
