This paper was the product of the Finance Committee's research into sources of revenue and expenses involved with solid waste. Malden spends approximately \$3.7 million on trash removal but only takes in \$1.2 million on blue bags and trash tags, which leaves a significant deficit. The current contract held with Republic has Malden's costs much lower that many of the surrounding cities. When that contract expires in FY 2032, the cost for waste and recycling is expected to jump dramatically.

There is also some speculation that the current provider, Republic, is looking for potential clauses in Malden's current contract that may increase expenses even before the contract expires. The purpose of this paper is a planning exercise to financially prepare for what may come.

Councillor O'Malley stated he has reached out to the attorney for the Malden Public Library Board of Trustees to discuss terms for dismissing his lawsuit without prejudice and that he hopes to solve the difficulties between himself, as the Council President, and the Trustees in a non-litigation manner. The purpose of this paper is to achieve that goal.

Councillor Sica offered to second a motion if Councillor O'Malley was seeking to refer this paper into committee, stating this should have happened weeks ago before litigation was initiated. It was the consensus of many of the members to agree with Councillor Sica that they would have preferred this paper as a starting point many weeks back.

Councillor Winslow offered to sit on this committee and work with the Trustees to find solutions, either through mediation or legislation. Councillor McDonald suggested instead of the Council President appointing a committee, they would rather see a joint task force that includes both Councillors and Trustees to work together in finding a solution. Councillor Colon Hayes suggested the possibility of hiring a mediator to assist with this situation.

Councillor O'Malley suggested that if the order was going to be referred, it should be sent to the Public Property Committee because the paper is in reference to an entity dealing with public property and assets. All were in agreement.

This paper, as sponsored by Councillor Colon Hayes, is to replace Paper 278-25 which was submitted by a group of concerned citizens for the purpose of allowing short-term, AirBNB-type housing rentals in the city. Councillor Colon Hayes agreed to sponsor this paper in order to bypass the fee of \$1,500 as required for a citizen led zoning amendment under the authority of MCC 12.32.050 and Council Paper 180-03.

City Planner Michelle Romero advised the Council to vet this paper thoroughly before sending it to the Planning Board for a public hearing, given the magnitude and complexity of this issue. If the paper is not referred within fourteen days of being received by the Council, to Planning Board for public hearing, it will have to come back before the Council to be re-referred, which can happen after the Council has taken its due diligence.

There was agreement that this is a complex paper that may effect quality of life issues, affordable housing, etc. The public should have an opportunity to hear more about the paper before it goes for a vote to the Planning Board. Additionally, any revisions that may be required should be done prior to referral for public hearing.

Councillor Colon Hayes advocated for this paper to go to the Community Engagement Inclusion Committee (CEIC) prior to going to Planning Board. She stated her intent that after having one or two meetings of CEIC for public discussion, then the paper could go to the Rules and Ordinance Committee for possible amendments.

Council President O'Malley introduced this paper by stating his desire to present this communication on the record for public disclosure without debating anything and that his hope is that it will just be placed on file.

President O'Malley then described each of the documents, which are attached to the history of Paper 309-25.

A motion was made by Councillor Linehan, seconded by Councillor Colon Hayes, that the Communication be received. The motion carried by the following vote:

After a vote to receive the communication, Councillor O'Malley went on to express that he did not feel as if he had the opportunity to explain himself properly at the last meeting. He is of two minds that this case should be discussed in Executive Session but also recognizes the public wishes to know what is going on regarding the case against the Malden Public Library Board of Trustees. Councillor O'Malley stated he contacted the defendants' attorney to propose they dismiss the case without prejudice.

Councillor Sica interjected that this conversation should have happened prior to him initiating the litigation and the communication should now be placed on file. Without trying to stifle debate, she said if Councillor O'Malley is going to discuss the documents, he should not be presenting from the Chair. Councillor O'Malley reiterated he doesn't intend on debating, this is just a communication but out of an abundance of caution agreed to vacate the Chair. Pro Temp Linehan then took over as presiding officer.

Councillor O'Malley then surveyed the members of the public sitting in Chambers by a show of hands who wished to hear further explanation. Councillor Linehan noted that it is up to the Council, not the public, whether they wish to hear from Councillor O'Malley then asked if there was a second to the motion to place the communication on file.

Councillor Sica stated she has no issue to place the communication on file but since the Council debated and voted two weeks ago to withdraw this litigation case, any further discussion is irrelevant to the Body. Councillor O'Malley disagreed and continued to explain how the lawsuit came to be. Councillor Linehan noted that all of these documents were not going to be read out loud into the record; they are online for anyone wishing to review. Having a motion and a second on the floor, she instructed the Clerk to call the roll.

Councillor Sica explained that she was advised the option to go into Executive Session should have been placed on the agenda but she does not agree with that recommendation. Any conversation regarding Paper 313-25 should be had in open session. She said the details of the Malden Public Library lawsuit have been made public enough that there is no reason why the following conversation cannot be deliberated on the floor. Councillor Sica wishes to withdraw the paper entirely. Councillor McDonald agreed that this discussion should be held in open session and seconded Councillor Sica's motion to withdraw.

Councillor Winslow suggested Paper 313-25 is not properly before the Body and therefore leaves no reason to enter Executive Session for a discussion that isn't allowable at this time.

Councillor Sica disagreed, stating she had spent the last week researching how these papers were to be put on the agenda. Council Rule 17.09 Disciplinary procedures shall be followed as set forth by Chapter 20 of Robert's Rules of Order Newly Revised. This is where the authority comes from to remove the Council President, not as a Councillor but from his seat in the chair. 10.01 speaks to annually choosing a Council President by majority roll call vote. Paper 314-25 will be a vote to suspend council rule 10.01 to allow for a second vote this year to choose another President. If the vote on 314-25 passes, the rules will be suspended at which point the Council may vote on a new president for the remainder of this calendar year per Paper 315-25.

Councillor Winslow asked for a point of order, claiming Paper 313-25 is not properly before the Council. Robert's Rules of Order Newly Revised (RONR) chapter 20, section 62 addresses removal of officer in one of two ways. He is of the belief Councillor O'Malley cannot be removed from the chair by adoption of a motion but rather requires a formal trial as explained in section 63. He argued Papers 313, 314, and 315 basically create an impeachment procedure that doesn't currently exist and asked for a ruling from the Chair. Councillor O'Malley asked for City Solicitor McNeil to come to the podium and brought her attention to RONR, 11th edition, page 654 which states if the bylaws provide an officer shall serve only a fixed term, an officer can be removed only for cause, that is neglect of duty or misconduct.

Solicitor McNeil read both of the two ways in which an officer may be removed; by vote or by investigation. The Council Rule book is silent on how to remove the President from the chair but the difference is if the rules state the President shall serve only a fixed term. The City Clerk argued the Council Rules do not state the President only serves a fixed term. A vote is taken annually but the Council President is not locked into a fixed term. They may serve multiple terms either consecutively or non-consecutively.

Councillor Sica reminded the body that when RONR speaks of removing a person from office, it does not mean the Council is voting to remove Councillor O'Malley from his position as an elected official, but only as the leader of the Council. The authority to vote for a Council President comes not by state law but rather Council Rules. Council Rules also allow for rules to be suspended, such as with Paper 314.

Acting President Linehan then asked the Council for questions so that everyone may confirm their understanding of what has been discussed. Councillor Colon Hayes commented that if the bylaws have no specific process written in place for this question, the Body should not be proceeding with the vote. Councillor McDonald attempted to move the discussion from the procedural to the point of where Councillor O'Malley has the opportunity to explain himself.

Acting President Linehan made a ruling from the chair that the paper is properly before the Body and a vote will be taken. Councillor Winslow made a motion to appeal the ruling of the Chair; that motion failed. Papers 313, and if needed subsequent papers 314 and 315 were ruled to be in order. Councillor O'Malley asked for the record to reflect that he formally objects.

After the question of Councillor Winslow's point of order was settled, the conversation

continued onto the merits of Paper 313.

Councillor O'Malley stated he thought he was putting the Council and the city's best interests at heart and he apologized to the Council for making the mistake of not informing them before the suit was initiated. He passed out a copy of an email sent to the defendants' attorney showing he was willing to talk about withdrawing the lawsuit.

Points of information were made that this email was dated for the day after this evening's agenda, containing the order to remove him from the chair, was posted. The email also had stipulations the Trustees must agree to before Councillor O'Malley would withdraw the case. Those points introduced conversation that Councillor O'Malley was not being sincere in his presentation or intentions.

Zaheer Samee spoke before the Council to clarify statements made during these proceedings, answer questions regarding the current status of the lawsuit, and offer procedures on how Councillor O'Malley may move forward in dismissing the case at this point since the defendants have already filed a response with the court.

Councillors Winslow and McDonald expressed concerns about misconduct and trust broke between Councillor O'Malley and his colleagues but they believe he is now willing to do right by the Council. They are willing to work to help build trust between the Council and the Trustees moving forward.

Councillors Sica, Crowe, and Spadafora expressed a general consensus that Councillor O'Malley continues to double down and defy the will of the Body. The paper to remove Councillor O'Malley as President didn't come as a result of him originally filing the lawsuit; it happened after Councillor O'Malley fought for an injunction to continue the case even as the City Solicitor appeared in court with a Council Order to withdraw.
