Chair Crowe handed the meeting over to Director of Strategic Planning Ron Hogan who passed out a handout of a comparison between the cities of Quincy, Taunton, Waltham,

Medford, Lynn, Salem, Somerville and Haverhill on the cannabis process for Zoning Passed, Principal Use Requirement, Buffer Zones and Special Permit. Mr. Hogan said the communities picked were similar to Malden. Mr. Hogan went on to say that the buffer zones were similar as it related to churches, schools, etc.but was difficult to compare because it depended on the zoning for that particular town.

Councillor McDonald thanked Mr.Hogan and said that what he presented shows Malden has more restrictions than most cities. With the zoning piece its not apples vs apples.

Chair Crowe said we want to get as much done as possible in Rules and Ordinances.

Mr. Hogan stated CLEC could continue entertaining licenses under the current rules.

Building Commissioner Miller said we have 1 license under appeal so there is one license available and CLEC has 3 applicants before them. Mr. Miller went on to say if you eliminate accessory use being prohibited it would allow a gas station that sells gum and cigarettes as a marijuana establishment. Mr. Miller used the recent construction of 10 building spaces at 888 Eastern Ave as an example of principal business use and accessory use. There are 10 individual business at one location, if a marijuana license was given out to one of the businesses it would comply to the ordinance because it would be principle use for one location while there are other businesses at the location.

Mr. Hogan and Mr. Miller addressed the suggested changes in 12.12.190.

Mr. Hogan suggested that in 12.12.190, section E "must be the principal use of the property and" be stricken from the section.

In section 12.12.190 section H.2, for the Security Plan it is a duplication in what is in the Host Agreement, it doesn't need to be in 2 places. Mr. Miller said there was a reason why the council put this in the zoning ordinance. This can be stricken from this section and add "and Malden Cannabis Licensing and Enforcement Commission" after Malden Police Chief in the first sentence and strike all language after.

Eliminate in section 12.12. 190 Section 9.a, the reason is the license from the state is one of the final steps and requires build out to be complete. This can be stricken from the ordinance

In section 12.12.190 Section 9.c. strike issued by the Malden License Board and replace it with issued by the Cannabis License and Enforcement Commission (CLEC).

Mr. Hogan said another topic worth discussion is Marijuana Transporter. The state has a delivery license now. If our ordinance stays as it is, Garden Remedies in Melrose can deliver to Malden residents but our marijuana licenses cannot deliver.

Councillor Sica stated we should change our ordinance regarding the transporter piece so our Malden businesses can deliver.

City Solicitor Fallon suggested striking the transporter definition and add in a courier definition.

Chair Crowe said the Courier piece needs some development, City Planner Romero said that Marijuana Transporter is in there and we could do it. We could turn it into a home delivery service, that's what a Marijuana Courier would be. Mr. Hogan stated we need to clean up the Marijuana Transporter section.

City Solicitor Fallon stated the courier piece is in committee now and can be addressed by the committee if there is a desire to allow an establishment to have a courier service deliver their product.

Commissioner Miller asked if the committee wants a new license for marijuana courier. Mr. Hogan said they will need time to develop marijuana courier.

Councillor McDonald handed out a sheet for the consideration of three amendments. Section 6.08.070 D.3 addressing Social Equity Applicants, 12.12.190 B.adding buffer zone. and 6.08.070 F clarifying typos in the Ordinance. Councillor McDonald acknowledged that it is a Catch 22 with the Board of Appeals in that they cannot grant zoning relief for variances regarding the buffer zones.

City Solicitor Fallon stated the Board of Appeals has a statutory authority under the law and if the council wanted to relax some rules they could review it.

Councillor O'Malley stated under current zoning, the applicant could petition the City Council under the special permit for relief. It is Councilor O'Malley's understanding that would be another path besides the Board of Appeal.

City Planner Romero said that the council did not grant relief for Dartmouth Street and 36 Charles Street in the Special Permit process, the Council made a finding to grant the Special Permit, there is a difference.

Councillor O'Malley said when the ordinance was passed, the Council did not understand the entire ordinance.

City Planner Romero stated that it was very clear at the time the ordinance was passed, Ms. Romero went on that both she and Building Commissioner Miller were part of the process and answered all the questions the council had.

City Solicitor Fallon stated that this need to be said into the Record, nobody has come to the City Council for buffer zone relief.

Building Commissioner Miller said buffer zones are not dimensional controls, dimensional controls are more to with issues like parking

Councillor Linehan stated we have been here for two hours, let's get some specifics.

City Solicitor Fallon told the committee on Councillor McDonald's first proposed amendment, you can't require the applicant to be a social equity applicant if you had other legitimate applicants before CLEC.

City Solicitor Fallon asked Building Commissioner Miller if he was OK with the Council determining buffer zones, Mr. Miller said to take it out of no man's land and put it in with the current zoning. Mr. Miller further stated that the applicant being referenced that was denied, went through the correct process.

City Solicitor Fallon stated nothing was done inappropriately, I don't even know why we are talking about it.

Councillor Linehan said the intent was to make recommended changes tonight in committee to be put on the council docket. Councillor Linehan made the following

motions to amend the Marijuana ordinance, seconded by Councillor Simonelli:

In Title12. Chapter12. Section190 E "must be the principal use of the property and" be stricken from the section.

In Title 12. Chapter 12. Section 190 H.2, add "and Malden Cannabis Licensing and Enforcement Commission" after Malden Police Chief in the first sentence and strike all language after.

Eliminate in section 12.12. 190 Section 9.a, the reason is the license from the state is one of the final steps and requires build out to be complete. This can be stricken from the ordinance

In section 12.12.190 Section 9.c. strike issued by the Malden License Board and replace it with issued by the Cannabis License and Enforcement Commission (CLEC).
