Councillor McDonald opened conversation on this paper with an explanation that Paper 74-25 was tabled for the purpose of giving the Solicitor's Office....

Assistant City Solicitor gave review .....

Councillor Winslow is in support of this paper. Is there another pathway where this issue could be helped. A declaratory judgment from the SJC? Could the Historical Commission apply on behalf of the church? Perhaps table the paper should be tabled pending further research.

Councillor Crowe asked if the grant could be used more appropriately if a community group submitted the application instead of the church.

Councillor McDonald: the SJC also says you can't unilaterally disallow a religious institution from applying solely based on their religious status. His recommendation on how he would proceed...... Would the church be open to remove the stained glass from the grant? Further legal scrutiny is required for any future CPC grants for religious institutions.

St. Paul's Parish is on the Historical Register for both the inside and outside structure of the church.

Councillor Condon not sure he would support this paper based on the need for consistency among various churches in the city.

Councillor O'Malley stated for the record full disclosure of his appearance of conflict of interest as a member of St. Paul's congregation. Asked how this legal review would affect non-profits. Read from Article XVIII Anti Aid Amendment.

A motion was made by Councillor Winslow, seconded by Councillor Crowe, that the Order be tabled. The motion carried by the following vote:
