This livery petition is for a multiple family dwelling with an illegal driveway on the left side of the house. The right side of the house is also paved for parking. There is no curb cut; cars must drive over the curb to get in/out of parking spots. An unregistered car was seen on the property with Uber and Lyft stickers on the vehicle. It is unclear if the livery license is meant for the unregistered car or a different vehicle. When Compliance Officers visited the house, there was no answer at the door. A notice was left on the car. The Committee is not prepared to approve a license for a resident that is out of compliance with current city ordinances. The recommendation is for Mr. Voltaire (Paper 431-25) to apply for an on-street parking permit for the livery vehicle and that the owner of the house apply for a curb-cut to accommodate the household parking situation.

Papers 430 & 431 are being tabled until Compliance can have a talk with the petitioner to clear up these issues.

Petition: Livery Driver: Jacqueson Voltaire, 64 Oliver Street, Malden (New)

This livery petition is for a multiple family dwelling with an illegal driveway on the left side of the house. The right side of the house is also paved for parking. There is no curb cut; cars must drive over the curb to get in/out of parking spots. An unregistered car was seen on the property with Uber and Lyft stickers on the vehicle. It is unclear if the livery license is meant for the unregistered car or a different vehicle. When Compliance Officers visited the house, there was no answer at the door. A notice was left on the car. The Committee is not prepared to approve a license for a resident that is out of compliance with current city ordinances. The recommendation is for Mr. Voltaire (Paper 431-25) to apply for an on-street parking permit for the livery vehicle and that the owner of the house apply for a curb-cut to accommodate the household parking situation. Papers 430 & 431 are being tabled until Compliance can have a talk with the petitioner to clear up these issues.

AGM has expressed interest in seeking changes to their special permit, which may affect the number of spaces allowed at their location; the owner is scheduled for a hearing on December 12th. After that hearing, the Committee will have owner Marcos in for an update to any changes that may take place with his company as well as compliance and parking arrangements. In the meantime, the committee agreed to recommend to the Full Council granting a conditional license for three months.

A motion was made by Councillor Taylor, seconded by Councillor McDonald, that the Petition be recommended with conditions to the City Council. The motion carried by a unanimous vote.
