#### 1. CALL TO ORDER

Council President Murphy called the meeting to order at 7:05 PM.

## 2. PLEDGE OF ALLEGIANCE & MOMENT OF SILENCE IN HONOR OF SERVICEMEN & WOMEN

A moment of silence was offered in observance of Malden Firefighter Gary J. LoPresti, Jr., who suffered a line of duty death and was laid to rest on September 1, 2023.

Representative from National Grid appeared to speak on this work order to bring new service via an underground trench to their customer's property at 90 Salem Street. Council President Murphy opened the public hearing. Noone spoke in favor of this petition. One person, Francis Walton, spoke in opposition on the basis that Holden Street has just been paved and she did not want to see the street ripped up again. Councillor O'Malley stated he spoke to DPW and National Grid about exactly that and the parties came up with an agreeable plan to restore the street and that he confirmed the area National Grid will be working on does not encroach on the portion of the intersection that was recently paved.

Councillor Winslow spoke on behalf of both Paper 302 and 303, stating the updates to Malden's storm water management and drainage ordinances are required by MassDEP and are mandated by deadlines in doing so. Both of these papers were created in Rules and Ordinance Committee in conjunction with City Engineer Yem Lip, as was approved by Council Paper 277-23 on June 27, 2023 so it is unnecessary to refer the papers back into committee. The intent is to vote to enroll both papers on the floor. Councillor O'Malley expressed his wish to send these papers back into Ordinance Committee as he does not think the updates go far enough above and beyond what is simply necessary by law.

Councillor McDonald in conversation with City Engineer learned the real goal of these updates is that any property in the city that could have a material impact by individual decisions on runoff should be reviewed by the City Engineer and that is what this ordinance update will accomplish. Further, once this piece of ordinance is passed then attention may be given to smaller properties and residential questions about runoff. How

storm water is managed is of great importance to the entire community as is witnessed by flooding in streets and school parking lots; it is Councillor McDonald's intent to revisit and review the runoff of these smaller parcels.

Both Papers 307 and 308, as well as a communication from Mayor Christenson, were read into the record collectively then discussion opened with a statement by Councillor Sica

Councillor Sica stated she proposed these two questions for the November ballot after being approached by a group of constituents seeking Council assistance. She further stated she is not anti-bus and bike lane but rather thinks further public input is beneficial for the entire city, in order to find a better way to make these lanes work for everyone. Councillor Winslow outlined all the public input over several years that has led to multiple successful projects involving bus and bike lanes and how the number of traffic accidents has dropped by 22% on Centre Street.

There was consensus among all the Councillors that a major cause of traffic back ups involving bike and bus lanes is that the lanes were painted by MBTA prior to getting the timing of traffic lights synchronized. Now, the timing of the lights has been worked on and so there is hope the traffic congestion will be eased. Also, there is the question of losing hundreds of thousands of dollars if Malden broke their MOU currently in place with MBTA, which is in effect until November 2024. All were in agreement that more public conversations are necessary and welcomed.
