**After reading of Paper #610-15, a motion was made by Councillor Crowe, seconded by Councillor Matheson, that the rule relative to carrying papers into the new biennial session be suspended and the Order be tabled for two weeks to allow members to review matters proposed for carry over. The motion carried by the following vote:**
