The discussion opened with Councillor Winslow giving a history of the paper. The purpose of adding the paragraph that amends the ordinance is to clarify the role of the Affordable Housing Trust Fund (AHTF), which is a legal entity that can help fund affordable housing. This paragraph serves to have the AHTF be recognized as the policy making body in collaboration with the Office of Strategic Planning and Community Development.

The Community Preservation Committee is fairly new they didn't spend any affordable housing money prior to COVID. The first they spent was to provide rent relief during the

pandemic but the main role of that money is not to provide rent relief, this just happened to be a very unusual circumstance. It should be clear that the purpose of that money was to help build and keep housing affordable. Additionally, the city now has an Office of Housing Stability to aid those who may get displaced. It may be beneficial to state the AHTF may be used to support housing stability.

Councillor Linehan added it should be made clear that there is policy oversight by the Trustees while working with city staff. Development, acquisition, and preservation as well as stability is all a part of the AHTF role.

After some discussion on how the proposed language would be made clearer, Councillor Winslow made a motion to amend the wording to read:

"The trustees shall act as the City's primary advisor on affordable housing policy, under the guidance of the Office of Strategic Planning and Community Development (OSPCD). In this capacity, they will create an affordable housing trust fund action plan, to include goals around affordable housing development, preservation, acquisition, and housing stability. Such plan shall be updated at least every five years, and will guide city officers, agencies, boards, commissions, and other city entities related to affordable housing policy."

A motion was made by Councillor Winslow, seconded by Councillor Linehan, that the Order be amended. The motion carried by a unanimous vote.

A motion was made by Councillor Winslow, seconded by Councillor Linehan, that the Order be recommended favorably as amended to the City Council. The motion carried by a unanimous vote.

A motion was made by Councillor Winslow, seconded by Councillor Linehan, that the Ordinance be taken off the table. The motion carried by a unanimous vote.

Chair Crowe asked to take paper from the table as she had an update to report. After having met with Mayor Christenson and BOH Director Chris Webb, it was decided this Food Policy Council would be better organized as an administrative policy managed under the Board of Health rather than a new ordinance. Much like when the city developed Complete Streets, having Food Policy Council as an administrative policy allows for more flexibility in the event any part of the policy needs to be updated as the council progresses. Changing an existing ordinance is much more complicated. This will also give the Food Policy Council the ability to go after funding and grants. The committee already agreed to this in theory as an ordinance, the suggestion is only to change the format to a Mayoral administrative policy overseen by the Board of Health.

Councillor Sica made a motion that the Order be amended to read as follows: Resolved: That it is the sense of the City Council that the Mayor consider the establishment of a Food Policy Council.

A motion was made by Councillor Sica, seconded by Councillor Winslow, that the Ordinance be amended. The motion carried by a unanimous vote.
