Title: Ordinance: Be it hereby ordained that Section 6.45 of the Revised Ordinances of 1991 as amended, be hereby further amended by adding the following:

- 1. The building commissioner and the fire department shall sign and approve the certified plot plan submitted with the license application.
- 2. That the principal of each dealership shall submit with the application a current CORI report issued by the Commonwealth of Massachusetts for review, inspection and approval by the City Council.
- 3. License fee for Class I, II and III shall be increased to \$200.00 per year.
- 4. Each Class I, II and III dealer at the time of application will pay a \$100.00 inspection fee.
- 5. That each new applicant shall pay a onetime application fee of \$50.00.
- 6. That no more than twenty-eight (28) licenses shall be issued; in addition to the sixteen (16) licenses allowed under Section E; (so called grandfathered licenses).
