Chuck explained this paper if related to the same salary schedule as discussed in Joint R/O & Finance (see attached). The library salaries as of 6/30/21 were the salaries contained in the F/Y 23 Budget that was discussed 6 months ago. The salaries for the Library were \$1,198,582.31 he applied 2.5% to that and got \$29,964.81 which is the cost to fund the contractual 2.5% COLA adjustment as of 7/1/21. He added the \$29,964.81 to the 1.1 mill figure and applied 2.5% to that number to compound the 2.5% COLA from the prior year so the cost to fund the COLA effective 7/1/2022 was \$30,730.93 for a total of \$60.678.74.

Councillor McDonald asked if the salary total includes the Library Director. Chuck said this amount includes everyone. The Library Director, Assistant Director and Clerk are not in the union. This figure is transferring a little bit of a surplus. The Director would receive what the non-union employees are receiving then whatever is contractually agreed by the newly formed union represented by Local 25, would go to the two other

City of Malden Page 1 positions, Assistant Director and Clerk, who have joined the newly formed union.

A motion was made by Councillor Simonelli, seconded by Councillor Condon, that the order be recommended favorably to the City Council. The motion carried by a unanimous vote.
