Public Comment on 350-25

Public Comment Sept 9 2025

This paper is being presented by Councillor Winslow as a follow up with the Mystic Valley Regional Charter School. Conversations were held during the summer to negotiate fair usage times for the newly renovated Trafton Park. The Councillor's intention is not to discriminate against staff and students of the Charter School but rather to balance the usage hours so local residents have the opportunity to also use the park during school hours. The \$2,500 per season suggested in the Councillor's proposal to the school is based on the bare minimum cost of \$5,000 annually to maintain the field. MVRCS used to apply for park permits when they were seeking exclusive park use. More recently, that practice has fallen away. Councillor Winslow made the affirmative outreach to the school but hasn't gotten adequate cooperation. He made clear that if the Charter School does not have a permit, they may not have use of the park.

Council President Linehan took a moment to explain the reason this paper is before the Council is because the Recreation Department policy states the Council has the authority to engage in a conversation for multi-year, heavy-user permits prior to approval. There are tiers of users and the Malden Public Schools are not part of the user tiers. This policy applies to parks, not to pubic school property.

Councillor Condon spoke on behalf of Ward 2 where the Charter's high school is located. He expressed appreciation for the way the school takes care of the neighborhood. MVRCS is a great school and its students receive an excellent education. With that, he trusts the Recreation Department staff with managing parks and permits in a fair manner. He is leaving it up to the recreation staff to develop a recommendation about how to proceed with the permit in this manner.

It is the view of Councillor Simonelli that fees for park usage should be equal across the board and not based on individual organizations. Further he explained Ward 7 has 5-6 parks of which he offered the use of to MVRCS while this issue with Trafton gets worked out.

Councillor Sica asked if heavy-use permits is a Council issue, why was the letter to MVRCS only signed by Councillor Winslow and why was the issue not brought before the

Body prior to opening a negotiation? She asked if the proposed \$2,500 fee was the idea of Councillor Winslow or the Recreation Department. In her view, this conversation began as a fee issue but has veered into something else that seems as if the Charter School students are not wanted at the park. She is not in support of this paper but will entertain sending Paper 350-25 to Public Properties for further review.

Councillor McDonald has heard much concern from the community regarding the Charter School's use of land, including the parks. They believe there is no pre-existing trust to build upon between the school and the city; this has been a strained relationship for quite some time. Would like to consider what other options there may be in this situation. MVRCS doesn't pay taxes; could there be a payment in lieu of taxes for an agreement around the park? This is a precedent setting agreement; they are not prepared to vote in support of this paper tonight.

Multiple councillors expressed concern about how the city manages and maintains parks in a fair manner and stated \$2,500 doesn't seem like a lot of money for exclusive seasonal use of an entire newly renovated park. Just the water bill alone runs \$1,300 monthly. Councillor Colon Hayes is willing to discuss this issue further, in committee, with the possibility of finding creative ways the city and the school may share resources to work this situation out. Councillor Linehan recommends taking up the discussion of Devir Park as well when Trafton is discussed in committee.

A motion was made by Councillor Winslow, seconded by Councillor Spadafora, that the Order be referred to the Public Property Committee. The motion carried by a unanimous vote.
