Paper 197-23 was tabled at the last session of Rules & Ordinance to give Legal time for an opinion on whether this amendment constituted spot zoning. That opinion is attached to the history of this paper.

Councillor O'Malley inquired when this paper goes to a full Council vote would this amendment only require a simple majority instead of a 2/3 vote in light of amendments made to M.G.L. c 40A by Chapter 358 of the Acts of 2020. Among these amendments are changes to section 5 of the Zoning Act, which reduce the number of votes required to enact certain kinds of zoning ordinances and bylaws from a ¾ supermajority to a simple majority.

A motion was made to retable the paper until Legal can offer an opinion on what these amendments will mean to the outcome of Paper 197-23.

A motion was made by Councillor Winslow, seconded by Councillor Sica, that the Ordinance be tabled to the Rules & Ordinance Committee. The motion carried by a unanimous vote.
