Ordinance Chair Winslow opened the meeting by asking City Planner Michelle Romero to introduce the Planning Board recommendations from the public hearing that was held on January 27 in a joint session of Planning Board and Rules & Ordinance. The document she read from is attached to the history of Paper 13-25 titled CCP 13 2025 PBR 1.25.

After Planner Romero's presentation, a number of votes were taken to determine if the Ordinance Committee would recommend to the full Council whether to accept the Planning Board's recommendations. In total, all recommendations were accepted with the exception of 7(c) regarding MCC 12.32.030.D.5 compliance with dimensional controls. Additionally, amendments were made to four of the accepted recommendations. There was a motion on the floor to approve most of the recommendations at once but the motion failed for not having a second after Councillor O'Malley requested each one be taken up separately.

The Committee then reviewed their own recommendations for amendments as originally presented by Councillor Winslow's addendum to the paper and Councillor O'Malley's additional suggestions as discussed in the January 21 meeting. Of all the amendments made during the January 21 meeting, only one was recommended out favorably for adoption by the Full Council.

A motion was made by Councillor O'Malley, seconded by Councillor Linehan, that the Ordinance be taken from the table. The motion carried by a unanimous

vote.

A motion was made by Councillor O'Malley, seconded by Councillor Linehan, that the Ordinance be amended by striking the last two sentences of 2(A) Applicability and replacing with 'Site plan review, is part of the building permit application and there shall be no additional fee for the site plan review. The motion carried by a unanimous vote.

A motion was made by Councillor Linehan, seconded by Councillor O'Malley, that the Ordinance be amended by striking 'City Councillor designated by the City Council President' in 4 Site Plan Review Committee and replace with 'Building Inspector (or designee).' The motion carried by a unanimous vote. A motion was made by Councillor O'Malley, seconded by Councillor Linehan, that the Ordinance be amended by adding a fourth bullet in 4 Site Plan Review Committee, (A) Composition and add 'Associate member appointed by Chair of the Zoning Board of Appeal'. (B) Quorum strike 'conduct any business' and replace with 'approve, approve with conditions, or deny an application for site plan approval, unless recused for a conflict of interest. Add (C) 'Voting by Simple Majority: A simple majority of the full membership is required to take any action.' The motion carried by a unanimous vote.

A motion was made by Councillor O'Malley, seconded by Councillor Linehan, that the Ordinance be amended by striking sub-section F in 4. General. The motion carried by the following vote:

- Yea: 4 Winslow, Councillor Linehan, Councillor O'Malley and Councillor Taylor
- Nay: 1 Councillor Crowe

A motion was made by Councillor O'Malley, seconded by Councillor Linehan, that the Ordinance be recommended favorably as amended by the previous four amendments to the City Council. The motion carried by a unanimous vote.
