# Minutes to be Approved

<u>577-18</u> Minutes of the Meeting of December 11, 2018.

A motion was made by Councillor Winslow that the Committee Minutes be approved. The motion carried by a unanimous vote.

#### **Business**

<u>273-18</u> Order: That prior to local licensure, initial community host agreements

for each marijuana establishment be subject to an open and public process, by the Malden City Council, subject to Mayor approval.

A motion was made by Councillor Winslow, seconded by Councillor Spadafora, that the proposed amendment drafted by Attorney Fallon on 12-18-2018 be further amended as follows:

Strike Section 6.49.4 {General Process} as set forth on Page 3 and amend 6.49.4 {General Requirements} as set forth on Page 4 as follows:

Items 1 & 2 to remain the same; item 3 to become item 5; item 4 to become item 3; item 5 to become item 4. All councilors present voting yes.

Councilor made a motion to strike from Section 6.49.1 manufacture and insert manufacturing; and after the word establishments insert the word may. All councilors present voted yes.

Councilor Winslow made a motion to amend Section 6.49.3 by striking the last sentence. All councilors present voted yes.

274-18 Order: Be it hereby ordained that the Malden Licensing Board be the

license approval authority for marijuana retail establishments, in

consultation with the Malden Board of Health.

of the Malden River, the Waterfront Access Committee, the

Conservation Commission, and the Planning Board to draft a zoning

amendment to require a setback from the Malden River.

The paper was introduced by Councilor Winslow who stated that the idea behind the paper was to give some teeth to the Conservation Committee. He explained that the Malden river is really not a river but a canal, as such it is not protected by the River Front Protection Act. That the buffer zone between development and the river/canal in Malden is only 25 feet. That the city with the aid of the conservation committee needs to increase the river/canal frontage.Councilor Winslow agreed to devlop an updated draft of the wetland By-Law for review of the Cosservation Committe. A motion was made by Councilor Mathenson to

table. All councillors present voted yes.

465-18 Be it hereby Ordained that Section 8.30 of Chapter 8 of the R.O of 1991,

as amended, be further amended by adding a new subsection, "K.,"

relative to Vacancies and Hiring.
