Hello David,

Thank you for taking the time to confer yesterday regarding a potential settlement and the filing of a motion to dismiss to revolve the matter. I am still preparing the formal motion but here is the high level proposal:

1. That the Plaintiff file a motion to dismiss without prejudice.
2. That the Defendants agree to work with the City of Malden in good faith, including providing access to relevant records, to clarify the relationship between the City of Malden and the Malden Public Library; and that both parties agree to give weight to the legislation chartering the library (Chapter 145 of the Acts of 1885) and the past pattern and practice of the Library Board of Trustees.
3. That both parties neither admits any wrongdoing, nor admits any weakness in their underlying positions.

If you think there are other relevant terms, then please suggest them.

As requested during the hearing last Monday, I wanted to share the attached authentic record which I obtained at the Malden Public Library. This annual report from 1960 and 1961 shows the long-standing pattern and practice of the Library Board of Trustees has been to recognize the full participation of ex-officio trustees. This is evidenced by 1. the Mayor traditionally being the vice president of the Library Board of Trustee and 2. both the Mayor and Council President serving on committees. I tabbed this document and provided it to the Library Board of Trustees at our June 12 meeting. There are over a century of similar annual reports which document this long-standing pattern and practice.

I truly hope that we can all take a step back and assess what is the best next step to resolve the conflict.
