Subject: Please Support Equal Access for Mystic Valley Students at Trafton Park

Dear Members of the Malden City Council,

I am a parent of a Mystic Valley Regional Charter School student. I am writing because I am deeply concerned about the City's new restrictions and proposed fees for Mystic Valley's use of Trafton Park.

For years, Mystic Valley children—including my own—have used Trafton Park for recess and physical education. This is a safe, nearby space where our kids can play, exercise, and build friendships. Taking that away, or attaching an unfair financial burden, would hurt our students.

What troubles me most is that these restrictions are not applied equally:

- 1. Malden Public Schools, like Salemwood and Linden, use City parks during school hours without fees, and playgrounds are even reserved for them with posted signs.
- 2. Other organizations with many non-Malden participants use City fields—including turf fields with lights—at no cost.

3. State PARC program and federal LWCF program requirements are clear: all Malden children should be treated equally, without discrimination based on what school they attend.

Mystic Valley is not asking for special treatment, only the same access other Malden schools receive: a non-exclusive, daytime permit with no fee. Families like mine have even volunteered over the years to clean and care for Trafton, and we are more than willing to continue supporting our park.

This is not about money—it's about fairness. Mystic Valley serves over 400 Malden children. My child, along with hundreds of others, deserves the same access to Trafton Park as every other Malden student.

I respectfully ask that you affirm equal access by granting Mystic Valley daytime, non-exclusive use of Trafton Park, including the playground, with no fee—just as you do for other public schools in our city.

Thank you for standing up for fairness and for supporting all Malden students.

I shortened my email by a couple of paragraphs in hopes it will now fit in the three minute time limit! Thank you:

To Mayor Christensen and the City Councilors:

I am a 15 year resident of the Maplewood neighborhood and I am writing to express my concern regarding the use of Trafton Park by the Mystic Valley Regional Charter School during school hours.

The charter school has used the Trafton field, tennis court, basketball court and even playground during school hours for many years.

The first time this directly affected me was in approximately 2015. I was on the field with my two preschool aged children, in the morning, along with a group of neighbors who had similarly aged kids. One of the neighborhood parents started an impromptu T-ball or kick ball game for our kids which was interrupted by a teacher from the charter school who had a group of students with her. She stated the school had a permit to use the field during the day and we needed to leave.

After that occurrence, one of my neighbors contacted the school and the City to complain, and we noticed decreased use of the park during school hours for a maybe a few years after that.

Since that time, I've had one incident where I left the park with my youngest child, again during the school day, because it was an unsafe environment for a toddler (rocks being thrown by students, etc).

Since then, I have read and heard about numerous similar accounts of residents being asked to leave the park or feeling it was unsafe to stay with a small child, quite a few times during the school day.

I'd also like to remind the Council that many families in our neighborhood do not have a yard for their kids and rely on Trafton Park for fresh air and exercise.

This park issue makes me wonder what my tax dollars are paying for. Should my kids be able to use the charter school's huge athletic turf field on Eastern Ave for a soccer or softball game when one of the Malden fields is rained out? That field is completely off limits to us.

And why can't my kids use St. Joseph's as a meeting spot for Girl Scouts anymore? It seems that the charter school has a new arrangement with the church that excludes Malden Girl Scouts from using it after years of doing so.

All this, and we've personally been kicked out of our own City park by this school. I've lived in six different cities and have never seen anything like this.

Mystic Valley Regional Charter School should pay the full price for the permit to use Trafton Park during the school day or find another spot to hold PE classes. Residents of Maplewood deserve to use the public park whenever they wish and not be asked to leave.
