Discussion opened with Councillor Crowe introducing the paper on behalf of Councillor Spadafora. This paper is specifically in regard to outdoor vending machines that dispense free or inexpensive water without regulation or permits of any kind.

Councillor Condon remarked he has been working with the owner of the water dispenser located on Highland Avenue for years to remedy the complaints he is getting from constituents. There are issues with noise complaints during all hours of the night; perhaps a fence will keep people from stopping there during off hours. Additionally, he suggested the Board of Health should get involved with learning how this water is even purified and to what standards. Councillor Condon is in full support of this paper and requested to be added as a co-sponsor.

A motion was made by Councillor Crowe, seconded by Councillor Condon, that the Ordinance be referred to the Rules & Ordinance Committee. The motion carried by a unanimous vote.

Resolve: Be it hereby resolved that it is the sense of the City Council that the Administration and Public Works Commission explore alternatives to the current water and sewer rate tiers to bring more equitable rates to two-family and other multifamily homes, including but not limited to, sub-meter account billing for individual units to reflect actual per unit consumption.

Councillor O'Malley spoke for the resolve, saying this paper was originally inspired by discussions with Council President Murphy and calls from constituents. He is interested in reviewing the tiers at which water rates are charged and to discover if some property owners may be using this as a means to up charge tenants for monthly water bills. Councillor O'Malley pointed out that this project may take some time for completion as the rates and tiers for this season have already been set. He has reached out for further information from Chuck Ranaghan and Yem Lip, is also interested in hearing from Dan Grover who was in attendance at the meeting.

Council President called Treasurer Grover to the podium to clarify issues for reevaluation. Rates are determined by consumption and are provided by the MWRA. The majority of MWRA communities do also used tier systems like Malden. Regarding submeter account billing: most new home construction has one meter because it is cost prohibited to have pipes running to two meters going to several different floors. The State requires the City to bill homeowners for water consumption, not the tenants. This allows for liening real estate property for non-payment by the owner. Owners are allowed to charge tenants for water usage but there is a process overseen by the State to be sure they are charging properly and not up charging the tenant.

Councillor Condon spoke of how in the past, consultant Doug Gardner had helped the City set the rates but he has recently passed and so we will be doing something different moving forward. This paper is a good way to open discussion on how the next person may do it. He suggested this paper be discussed with the Finance Committee for further review.

Councillor Linehan stated having this conversation is a great opportunity to learn more about how we educate new residents and tenants on what rights and resources are available either through new resident packets or through Office of Housing Stability. Councillors Colon-Hayes and McDonald both thanked the sponsor for bringing this paper forward. McDonald said he would be happy to schedule a time with the Treasurer's Office to discuss further. Councillor O'Malley requested Assistant Collector Stacey Winn to sit in on further conversations.

All councillors in attendance asked to be added as co-sponsors to this paper.

A motion was made by Councillor O'Malley, seconded by Councillor Colon-Hayes to move this topic of discussion into a joint session of the Public Works/Finance Committee for further evaluation. The motion was passed by a unanimous vote.

Resolve: Be it hereby resolved that it is the sense of the City Council that the Massachusetts Senate and House must enact, during the current legislative session, HR4931, An Act Relative to Pesticides.

According to the MSPCA Angell Animal Hospital, "Second Generation Anticoagulant Rodenticides (SGARs) are a type of poison used for rodent control that work by stopping the blood clotting processes, causing lethal hemorrhage. SGARs have been extensively used for rodent control, allowing secondary exposure and poisonings in non-target wildlife species, such as birds of prey that mainly feed on rodents or small birds. SGARs are prohibited for residential consumer purchase in the

Commonwealth, but commercial use is allowed for licensed pesticide companies when hired to deal with rodent problems."

Councillor O'Malley stated his passion for this topic as an animal lover, former park ranger, and dog owner. He said that although he utilizes services for in-home pest control, outdoor bait traps can be accessed by non-target animals such as squirrels who then become a toxic part of the food chain. It is a gruesome sight to see an animal who is poisoned in this way and Vitamin K is an antidote, recommended pet owners keep a supply on hand from their veterinarians. Reminded people that this legislation is not to ban products but rather to study, which is important because of the impact that it is having on our wildlife and domestic animals.

Councillor Colon-Hayes supports this resolve especially since it supports a study and also because she has had residents and friends who have reached out to her about sick or dying cats. She does not view this paper as a call to banning these products but as a great opportunity to study and learn more about the subject matter.

Councillor Winslow said for the first time in his neighborhood he is seeing dead rats out in the open and with eagles now back in the City this is a big area of concern. He does have hesitation with the House number as listed on this resolve. When Councillor Winslow went to do further research he saw that HR4931 seems to have has morphed into something else and it's too important legislation not to get the resolve correct. Made a recommendation to table until this information can be confirmed. Councillor Linehan seconded this that she also tried to look up the number and couldn't find it.

Councillor Linehan went on further to speak about a ward three resident, Linda Amato, a wildlife rehabber who was helping to educate the councillor on this issue. Living near the Fells Reservation, Councillor Linehan has seen an uptick with birds of prey in her area and it is important to be conservation minded especially with the food chain. Although she is a Yankee pest Control subscriber, she also wants to be fully informed on the use of these rodenticides.

Councillor Condon believes it is good to bring awareness to this issue but has faith in the professional opinion of Galvin Murphy, therefore is in favor of tabling this resolve to make sure we are getting it right. Councillor O'Malley is in favor of tabling this resolve for two weeks until the new legislative session is able to refile this paper with an updated bill number, which must be done by January 20.

Councillor President Murphy is supportive of protecting the wildlife in her ward but she also has constituents in Ward 5 that are inundated with rats and we need a way to control them. She also wished to point out that Vitamin K must be handled properly when being used on domestic animals, as it depends on breed, size, type of poison, and results of blood test. Please see your veterinarian prior to giving your animal vitamin K.

A motion was made by Councillor O'Malley, seconded by Councillor Winslow, that the Resolution be tabled to the City Council. The motion carried by a unanimous vote.
