RE: National Grid Petition – 71 Porter Street

National Grid requests permission to locate poles, wires, and fixtures, including the necessary sustaining and protecting fixtures, along and across the following public way:

Porter St. – National Grid to install 1 JO Pole on Porter St. beginning at the intersection of Porter St. and Starbird St. and continuting approximately 30 feet in a northeast direction. National Grid to install one (1) 35 ft. stub pole (P4759-84 is approximately 30 ft. off existing pole 4759 at the intersection of Porter St. and Starbird St.

In accordance with the requirements of Chapter 166 of the General Laws, you are hereby notified that a PUBLIC HEARING will be held on **June 30th at 7:00 PM** on said petition. The hearing will be held remotely (information below):
