Be it ordained by the Malden City Council that the Code of the City of Malden (MCC) 6.12.010 HOURS OF OPERATION; IN GENERAL is hereby amended by adding under Paragraph A: Retail Car Wash 8:00 AM to 6:00 PM

Councillor Winslow began the discussion by explaining that there have been noise complaints from a resident on Lodgen Court in the past about the car wash located at 62 Broadway. Councillor Sica visited the area on Lodgen Court and wasn't able to hear noise from said car wash. Councillor Winslow mentioned there haven't been any complaints recently.

Councillor O'Malley stated because car wash isn't defined in the ordinances, car washes can go in anywhere, such as the location across from Pine Banks on Main St. The noise may cause an issue in the neighborhood.

Councillor Sica asked what would the proposed definition of a car wash be and would it include detail shops. She didn't want to affect small businesses. A detail business on Broadway is considered Retail Sales and can be open until 11pm. She went on to suggest the committee wait to vote on establishing hours of operation until after the car wash use has been defined in the zoning ordinance.

There was limited discussion about decibel studies on current and proposed car wash locations in the city.

Motion was to table this paper until after the December 11, 2024 Planning Board Public Hearing.

A motion was made by Councillor Sica that the Ordinance be tabled. The motion carried by the following vote:
