#### **Other Business**

Be it ordained by the Malden City Council that the Code of the City of Malden (MCC) 6.08.100 Subsection A 2(b) USED CAR DEALERS is hereby amended by striking it in its entirety and inserting the following in its place: 'a release signed by the applicant, authorizing city personnel to access the applicant's criminal record;'

City Solicitor Alicia McNeil informed the Committee the Director of the CORI Board reached out to her about a complaint against the City regarding a CORI report being talked about during an open meeting. She also explained that our current ordinance 6.08.100 Subsection A 2(b) requires individuals to submit their own CORI report with their application for a Class I, II, III license which is out of compliance with MGL c. 6 Sec. 172. The City cannot require individuals to submit their own CORI reports.

The proposed ordinance amendment would require applicants to sign a release form, which is valid for one year, authorizing city personnel to access their criminal records which would be in compliance with the MGLs.

Chair Sica asked how to handle applicants who had already submitted their own CORI reports with their license renewals. Solicitor McNeil advised that these applications would remain valid until the next year, after which the new procedure would apply.

Solicitor McNeil mentioned that her office is working with the HR Department to develop a formal policy for handling CORI requests, ensuring strict compliance with legal procedures. The policy will clarify which city departments are responsible for gathering CORI information.

Councillor Colon Hayes asked whether the City would need to pay to pull these CORI reports moving forward. Solicitor McNeil and Assistant City Clerk Hunte confirmed that there is no cost to the City, and that they have an account to access CORI information directly through iCORI.

A motion was made by Councillor Colon Hayes, seconded by Councillor Condon, that the Ordinance be referred to the Rules & Ordinance Committee. The motion carried by a unanimous vote.

# Adjournment

A motion was made by Councillor Taylor, seconded by Councillor Colon Hayes, that this meeting be adjourned. The motion carried unanimously. Meeting was adjourned at 5:47 PM.
