8. MOTIONS, ORDERS AND RESOLUTIONS

Be it ordained that Section 1.2 of R.O. 1991 be amended relative to invalidity or unconstitutionality of ordinances.

Be it ordained by the Malden City Council that the Revised Ordinances of 1991 as amended be and the same are hereby further amended as follows:

-by adding at the end of Section 1.2 the following new paragraphs: Any provision or part of this code which conflicts with state or federal law shall be invalid; provided that, for purposes of this section, federal law shall take priority over state law.

A written determination by the City Solicitor, the Massachusetts Attorney General, the United States Attorney General or any federal law enforcement official shall be sufficient to render a specific section or sections invalid.

No officer or employee of the city shall take action to enforce any section or part of this code which has been determined, in accordance with the preceding paragraph, to be invalid and, any action so taken, shall relieve the city of any obligation to indemnify said officer or employee for any damages arising therefrom.

Supervisory personnel in the Public Works Department shall receive such longevity benefits and clothing allowances as they would be entitled to if covered under the Public Works collective bargaining agreement. No other benefit granted to employees under a collective bargaining agreement shall be extended to any employee not included

in the bargaining unit.

9. COMMUNICATIONS

Mayor's Veto of Paper #224-14 (Reducing fees for Solid Waste Collection)

Dear Members of the City Council:

I write to let you know that I am returning, unsigned, the ordinance amending Section 9.28 of the Revised Ordinances of 1991 which reduces fees for the collection of solid waste. I submit the following objections for your review:

- The legislation comes at a time when our finances remain in a
 precarious position. We continue to run a structural deficit of
 approximately \$3-4 million on an annual basis. I believe we need
 to thoroughly evaluate the financial impact of any changes to the
 current program so that we can all be assured that we can
 maintain the delivery of services that our residents have come to
 expect and deserve.
- The ordinance does not address what many of those opposed to the program have advocated for which is the outright elimination of Pay As You Throw (PAYT) or at the very least an alternative which would preclude the need to purchase bags for the disposal of solid waste.
- 3. There is also the unknown factor that this amended ordinance would have on our current recycling rates. The positive impact of the current program has not only been the reduction in trash volume but also the increase in recycling. We presently recycle an average of 30 to 40 percent of our solid waste which translates into hundreds of thousands of dollars saved. Any change to PAYT could negatively affect this percentage.
- 4. This amendment does not address what we have repeatedly heard to be a prevailing problem which is the mess that the open 18-gallon recycle bins are making throughout the city. Public Works Director Bob Knox has stated that if he could change one thing it would be to increase the capacity of the recycling bins and require covers to better contain our recyclables.
- 5. Finally, this ordinance does not take into account the recommendations made by the panel of residents who spent over a year working on alternatives to improve our program. I believe it is a lost opportunity not to take advantage of their hard work and dedication.

As always, I appreciate your time and effort on topics like this but I believe an amendment of this importance requires more time and thoughtful dialogue, both internally and with the public, prior to any change. As evidenced by the 5-4 vote to ordain the paper, it is clear the Council is divided on the matter.
