Strike:

2.12.170 RECREATION PROGRAMS/RECREATION COORDINATOR

The Mayor shall designate a Recreation Coordinator, who shall serve at the Mayor's pleasure and shall, in consultation with the Stadium and Athletic Field Commission, develop and coordinate a comprehensive plan to make recreational activities, programs, events and facilities available to residents of the city. The Coordinator shall hire such subordinates and assistants as may be provided for by appropriation.

- 1. The Recreation Coordinator may apply for grants and awards from state and federal agencies, may seek funding from private organizations and may engage in private fundraising, provided that all funds so acquired be deposited in the City Treasury and expended as allowed by law.
- 2. The Recreation Coordinator may issue permits for the use of fields, parks, stadiums and other municipal recreational facilities which are now or from time to time designated as available for use by the public.
- 3. Each permit shall specify the days, hours, activities and facilities or portions of a facility to which it applies and shall entitle the permit holder to exclusive use of said facility or portions of said facility for the duration of time specified on the permit; provided that use of a permitted facility for any activity not authorized by a permit shall render the permit null and void.

2.12.170 DEPARTMENT OF PARKS AND RECREATION

- A. The Department of Parks and Recreation shall be under the direction and control of the Director of Parks and Recreation, who shall be appointed by the Mayor, with City Council approval, from a minimum of 3 candidates identified and recommended by the Board of Park Commissions. The term of the Director of Parks and Recreation shall be 3 years.
- B.  - a. The Malden Park Rangers unit shall report to and be hired by the Head of the Malden Park Rangers.
 - b. The Malden Park Rangers shall be deputized by the City of Malden and the relevant officers thereof, to enforce city ordinances, state laws, and write citations.
 - c. The Malden Park Rangers shall be unarmed at all times and shall coordinate with Malden Police, Massachusetts State Police, and any other law enforcement agencies of the Commonwealth of Massachusetts, when needed.
