# BENEFITS: Why a Youth Board?

- Assists the city in addressing the needs of the youth
- Gets youth involved in multiple aspects of city government
- Helps Malden Youth understand role of elected officials
- Fosters a sense of empathy
- Create a stronger future
- Instills positive feelings

# **EXISTING GROUP: Malden Youth Civics Council**

#### Pros

- 1. Tries to Engage Youth in Government
- 2. Addresses social issues within the community



#### Cons

- 1. Only represents students at MHS
- 2. Membership is unstable as an afterschool club
- 3. Harder to communicate and create influence in city government
- 4. No direct input in city decisions

#### THE SOLUTION: City-wide youth board

- 1. Attend Bi-weekly board meetings
- 2. Members will appoint one member to attend city Boards and Commission meetings
- 3. Assist and help advise on city events, projects and other duties as needed
- 4. Connect to the youth community for city events and announcements
- 5. Present to the Council their goals, agenda and mission Quarterly to the City Council
- 6. Aid in the Climate Action Plan committee

#### THE SOLUTION: City-wide youth board

- The City Council shall be responsible for the organization of this new committee
- Creation supported by community groups like Malden Youth Civics Council(MYCC)
- Review process will begin with the Appointments and Personnel Committee offering interviews with recommendations to the Council floor for final acceptance
- A paid adult advisor shall be hired to guide the Youth Board, under a specific department or position

#### THE SOLUTION: City-wide youth board

- All meetings must be open to the public.
- The members shall appoint a Chairperson and Vice Chairperson
- Youth board members shall receive stipends for their time spent in the meetings.

## **Member Qualification of Youth Board**

- 1. Remain residents of the City;
- 2. Attend youth council meetings as well as the liaison committee meetings on a regular basis and inform these committees of absences prior to meetings;
- 3. Fulfill the responsibilities of the office held; set an example for youth in the community.
- 4. All members shall be between the ages of 13-20 years old.
- 5. The term of each member shall be one (1) year following city council term years.
- 6. Members are eligible to reapply annually if they meet member eligibility requirements with a term limit of (3) years.

\*Can be removed from the Youth Council if they fail to sustain any of the above qualifications
