



Green St Park doesn't resemble a baseball field at all





Let me first start off by thanking you for your time and service to the City of Malden.

I am a forever Malden resident. Malden Public School system with daughters that are at Mystic Valley now and one started out at Forestdale School. I speak as a parent first, resident and youth softball, Pop Warner Football and current Malden Catholic Football Coach.

I understand both sides to the natural grass vs turf debate. I am on the side of turf for Roosevelt. There are many reasons for this and I know you all have heard both sides. I have coached on turf for as long as it started from East Boston with the old school carpet to when it was first installed at Pine Banks and Malden Catholic. With the hundreds and most likely thousand to 1500 kids I have coached have I seen or heard of any turf related injury or illness. I am not a medical expert but seeing is believing. There are a few exaggerated stories out there Nationally and as a whole there is no proven link to any turf related health issues. Some studies but nothing of proof or of real substance.

I respect the teachers and parents that prefer grass. It seems there are the same group of teachers that has stopped this from happening in the past and it would be a shame if this happened again and Roosevelt was left as is yet again. Roosevelt Park was a park long before it was a school.

The advantages my daughter has using MV turf for softball is huge. Countless times over the past few years teams come in to play the first few weeks in April and tell us how their girls have not been outside for practice(due to Northeast weather) and they are playing their first game which is a huge disadvantage.

People want to talk about turf being hotter in the sun. Which it is. But we are in New England not Arizona. I've been on turf when it's 90 and humid and it's fine with proper rest and water breaks. Heat is really not an issue in my opinion. Roosevelt will get used alot more both recreationally and the kids at Salemwood School will be out alot more for recess. Not ruining school shoes or sneakers running in wet grass or some soft wet dirt after finally getting out on the field after it rained 2 days ago. The benefits for the school children and youth groups of Malden is the reason this should be approved.

There are a few loud people in the city that do not use these Parks and sit behind their keyboards and and google search articles and studies. That's not who Roosevelt Park is for. They have a right to their opinion but the opinions expressed aren't from a perspective that is informed or realistic.

It's time to move past the same opinions from 7 years ago. They have the same argument and there is no new information saying turf is unsafe.

Dear Councillors,

First I would like to thank and commend you on your commitment to serving the City of Malden. Specifically in regard to the amount of time and effort all of you have put into the Roosevelt Park Improvement Project. My name is Charlie Conefrey (220 Middle Street, West Newbury, MA. 01985), and I am the Director of Athletics, Physical and Health Education for the Malden Public Schools, K-12. I am reaching out to you today to express my continued support for the Roosevelt Improvement Project. In a previous letter sent to the council I expressed my memories of growing up at 19 Waite Street and the hundreds of hours spent on the Roosevelt field playing youth sports as well as playing with my friends some 25 years ago. I have fond memories playing on that field, however the field condition today is not much different than it was over two decades ago.

I feel strongly that we are doing our children, youth and adolescents a disservice by not providing a state of the art, multi-use, safe playing environment. Neighboring communities (Everett, Somerville, Revere to name a few) have continued to make considerable improvements to their play areas throughout their cities. Specifically, play areas in the form of turf fields many of which are adjacent to K-8 public schools.

Throughout this process I have heard the opposition, and I must say that I respect their points of view and even agree to a degree. I agree that it is important and vital to protect green space where appropriate, especially in urban areas. In a perfect world without fiduciary concerns, I would advocate for all of our fields and playing areas to remain natural grass and I think most would agree. However, the maintenance of a natural grass field with continued high use cannot be overlooked and in my opinion out of the Malden DPW's capability.

Furthermore, it is important to note that the Department of Public Works for the City of Malden has and continues to do a tremendous job under the direction of Mr. Knox. In fact, I would say an exemplary job maintaining our current green space playing areas on top of the numerous other responsibilities Mr. Knox and his team currently perform. Putting further stress on our DPW by going in the direction of natural grass field of this size also has financial implications. Including the amount of time and care it would take to properly maintain a natural grass playing area the size of Roosevelt Field would put strain on the Malden DPW, a strain I feel is unnecessary. At the last city council meeting suggestions were put forward to help protect existing green space in other areas of the city. I fully support this initiative and look forward to hearing more.

The Roosevelt Field Project as proposed has the potential to meet and exceed the needs and expectations of thousands of youth for years to come. A valid and imperative point that cannot be overlooked is the social emotional needs of our students, families and other community members. During a time of great angst and increased levels of stress and anxiety, the perfect medicine is physical activity, especially physical activity that can be done outdoors nearly year round. The current condition of the Roosevelt field does not provide such opportunities. We at the Salemwood School are limited in our ability to provide outdoor playing opportunities for our approximately 1200 students due to the field's current condition.

It is no secret that the COVID pandemic has caused numerous issues. Included in these issues due to quarantine restrictions is time of play. Increased time of play is needed now more than ever before. Peer to peer interaction is an absolute necessity to the overall well being including socially, emotionally and physically. I have heard the opposition points on the cost of the project being too much and how can the City of Malden afford such an expense during a pandemic. I would argue, how can we not? I see this as an investment in our children, in our youth, in our city.

As an employee of the Malden Public Schools I have and always will continue to make decisions based on what is best for our children. A perspective that is student centered is imperative as we navigate through difficult times. Our youth deserve the best opportunities and it is our responsibility to do everything we can to provide such opportunities.

In closing, I continue to offer my full support of this project moving forward. If you would like to discuss further I would be happy to hear from you!

Coaching softball the last 10 years in Malden, I have had to deal the field conditions at Salemwood from the poor drainage to large divots in the outfield.

The biggest complaint would be the 4:00 storms that would roll-in before a night game that lasted 25 minutes but would cause 3 days of cancellations. With a turf field, this would not be an issue.
