#### 4. GUESTS, CITIZEN ACHIEVEMENT AND ANNOUNCEMENTS

Historian and local author Inna Babitskaya will appear before the City Council to present her book "Time of Converse".

Local author/historian Inna Babitskaya was introduced by Councillor Linehan and Ms. Babitskaya had a slide presentation on her book "Time of Converse" and walked through the history of the Converse family and the impact they had on Malden.

City Engineer Yem Lip will appear before the City Council to provide an update on the signalization and lane striping project on Centre Street/Route 60.

Council President Spadafora turned the meeting over to Councillor Crowe who thanked Mr. Lipp for coming and referenced the memo the mayor has forwarded to the Council earlier in the day that outlined the timeline and thought process behind the process. Mr. Lipp suggested for those councillors that had not read memo he had brought copies.

Councillor Crowe made a motion to take a two minute recess to give councilors the chance to read the memo, Councillor Condon seconded the motion and it was so voted by unanimous vote. Councillor Crowe requested that the mayor's memo be included in

the minutes. Mr. Lipp handed out the mayor's memo to the Council. The meeting recessed at 7:42 p.m.

Councillor Crowe made a motion to come back into session, the motion was seconded by Councillor Condon, it was so voted by unanimous vote. The meeting came back to order at 7:47 p.m.

Councillor Crowe asked Mr. Lipp for any updates. Mr. Lipp answered that he didn't have much to add to the memo. Mr. Lipp added that he did have a conversation with the MBTA around the MOU that they are tweaking and the hope was to get the MOU back signed and we could continue with the project.

Councillor O'Malley stated he caught up with Mr. Lipp and would move to empower the city to complete the MOU.

Councillor Winslow said he was pleased to work with Mr. Lipp and the city has made a lot of progress and asked Mr. Lipp if he was confident that Pine Ridge would be able to get the work done on the traffic lights.

Councillor McDonald said he appreciated the memo because it explained how we got here. Councillor McDoanld continued, we striped the roads before the lights were timed properly and we need to front the money to fix them and the MBTA will reimburse us. Councillor McDonald added that is very supportive to get this done as quickly as possible but we have to get it right.

Councillor Murphy said we have had a lot of good conversations but she thought like some of her fellow councillors that the striping was temporary and she only feels comfortable that they see the MOU about the financing. Councillor Murphy added we were told the police and fire could use the bike lane but they do not want to use it because it would confuse drivers about pulling over. Councillor Murphy said she is hesitant about moving forward with the project not knowing if it is temporary or what she is now hearing for 3 years.

Councillor Linehan said the council needs to be respectful of department heads and at the same time we need to get things done. Councillor Linehan added that grant programs sometimes makes the planning be rushed and she felt that was the case with this project.

Councillor Condon said he was never a fan of the project and from the beginning he felt the problem was with the signalization. Councillor Condon continued if we come away from anything with this project, hopefully people can cross route 60 and bikes can travel safely.

Councillor Winslow said that at the time of this project the Transportation Planner that was hired was only on the job for a year, these are the types of projects he will be able to help out on.

Councillor Colon Hayes suggested the council have the Transportation Planner come before them at a future date.

Councillor Sica said we are in the mess we are in because of the MBTA and that he only voted for the paper so the signalization could be corrected and she liked the fact police and fire could talk to the lights, the signals were the key to the project and the problems have nothing to do with Mr. Lipp.

Council President Spadafora said Mr. Lipp and the Transportation Planner need to be involved with these projects., they are the professionals and everyone is agreeing on that. Councillor Spadafora added that he feels everyone in the room is at fault, we allowed the MBTA to paint the lines, President Spadafora continued that he and Councillor Crowe were participating in zoom calls with the MBTA and there were no updates for 5 months and that he is dead set against a 3 year commitment and that he would support a 1 year MOU but wouldn't vote on it until he saw the MOU. Council President Spadafora ended by saying he hopes it works but doesn't think it will.

Mr. Lipp said the project should be completed by April.

Councillor O'Malley made a motion as a Resolve that the Council empowers the city to move forward with an MOU with the MBTA on the project.

Clerk Lucey advised that the item is not a docketed item so no vote should be taken.

Councillor O'Malley stated the Council could make motions from items that are on the agenda and discussed and the motion flowed from the discussion and it does not violate any rules.

Councillor Crowe said that she did not feel any vote was necessary because discussions on the MOU are already in process.

Councillor Colon-Hayes said that she would second the motion and if the vote doesn't mean anything, have the vote to at least show support that the Council wants the MOU to move forward.

Council President Spadafora asked that City Solicitor McNaught give an opinion on the Council voting on Council O'Malley's resolve and it not being on the docket.

Attorney McNaught said he agreed with Clerk Lucey.

Council President Spadafora said if Councillor O'Malley had a second they would take a vote, Councillor Colon-Hayes seconded the motion. The following vote was taken: Colon-Hayes (y), Condon (n), Crowe (n), Linehan (y), McDoanld (n), Murphy (n), O'Malley (y), Sica (n), Winslow (y), Spadafora (n), motion failed 4-6.

Councillor McDonald requested that the minutes reflect that although Councillor O'Malley's Resolve failed to take a vote on the resolve, the consensus of the council that it was in agreement that the city move forward in getting a MOU agreement with the MBTA.
