Mayor's Letter to the Council re PCAC Ordinance

Prior to Councillor McDonald speaking on this paper, a letter of support from Mayor Christenson was read into the record. Letter is attached to the history of Paper 81-23. This paper originally began with the Mayor's request to review the police department's use of force; this opened a dialog with the community and over 1,300 Malden residents were surveyed on potential recommendations. These recommendations may be viewed on the city's website. The vision for this council is to review data as it's published annually by the police department to then discuss policy, strategy, how the work of the police department intersects with other public safety groups. Councillor McDonald further stated Chief Cronin is in support of this paper.
