The Finance Committee will hold a Public Hearing regarding the proposed FY 19 Budget.

281-18 Annual Appropriation order for FY2019.

A motion was made by Councillor Winslow, seconded by Councillor Anderson, that the Order be amended by cutting \$40,000 from the City Budget and recommend it be moved overt to the School Budget to increase the ELT teachers pay at the Ferryway and Salemwood School. The motion failed by the following vote:

Yea: 2 - Councillor Anderson and Councillor Winslow

Nay: 4 - Condon, Councillor Camell, Councillor Crowe and Councillor Murphy

A motion was made by Councillor Murphy, seconded by Councillor Crowe, that the Order be amended to request the Mayor add \$24,700 to the Board of Health budget to fund a part-time nurse. The motion carried by the following vote:

Yea: 6 - Condon, Councillor Camell, Councillor Anderson, Councillor Crowe, Councillor Murphy and Councillor Winslow

A motion was made by Councillor Anderson, seconded by Councillor Murphy, that the Order be amended to request that the Mayor find ways to hire more people of color and diversity by spending additional money when advertising job postings in both the City and Schools. The motion carried by the following vote:

Yea: 6 - Condon, Councillor Camell, Councillor Anderson, Councillor Crowe, Councillor Murphy and Councillor Winslow

A motion was made by Councillor Murphy, seconded by Councillor Camell, that the Order be amended that the Mayor add \$50,000 to the Public Facilities budget to fund the installation of a snow cage at the Forestdale School. The motion carried by the following vote:

Yea: 6 - Condon, Councillor Camell, Councillor Anderson, Councillor Crowe, Councillor Murphy and Councillor Winslow

The Finance Committee continued deliberation on the proposed FY 19 Budget and discussed the letter that was presented from City Clerk Tom Brennan to propose finding funding for new voting machines for future elections.
