#### **Business**

- <u>449-18</u> Be it hereby Ordained that Chapter 7 of the R.O. of 1991, as amended, be further amended by adding a new section 7.29 relative to The Use of Recyclable and Reusable Bags.

Councillor O'Malley introduced the paper, and then asked the sponsor, Councillor Camell to talk about the reasoning behind the paper. He explained it was to protect the land and marine environment and minimize litter. Councillor Camell then introduced Ms. Lana Santos Albuquerqueto, an eleven year old student at Mystic Valley Regional Charter School to speak about the paper. Councillor Matheson asked if any one has reached out to the business community, the committee was informed that Kevin Duffy, of the Mayors office, has reached out to the community. It was further explained that large retailers would have to comply with the ordinance within six months, small retailers would be given nine months to comply. The chair stated that he has not heard any opposition to the paper, neither had **Councillor Camell.** Council President DeMaria stated she supports the paper, and that we should bring in Mr. Duffy and have a public hearing. Councilor Winslow made a motion to have a meeting on the issue with the the Citizens Engagement Committee so that all sides can be heard. Councillor O'Malley vacated the chair so that he could second Councillor Winslow's motion to refer to the Citizens Engagement Committee, the motion passed unanimously.

The Citizens Engagement Committee did not give a report to the Rules & Ordinance Committee about the Public Meeting held Nov. 15, 2018 regarding reducing the voting age in Municipal Elections for the City of Malden, because members were absent.
