Ordinance: Be it hereby ordained that the Revised Ordinances of 1991 be stricken effective January 1, 2020 and the Revised Ordinances of 2020 become effective on that date.

Karen Anderson appeared before the committee to review her work regarding cleaning up the Revised Ordinances of 1991 that will get incorporated with the Revised Ordinances of 2020. Ms. Anderson told the committee revising the Ordinances are long overdue and necessary with the upcoming change to Municode for the tracking of City's Ordinances and not having been revised since 1991. Ms. Anderson organized the Ordinances in the way recommended by Municode and took out any outdated Ordinances or unconstitutional and unlawful Ordinances. Ms. Anderson stressed the changes were not policy changes. Councillor Winslow noticed some typos and will work with Ms. Anderson until the end of the year to correct errors. Ms. Anderson recommended that the paper be voted out favorable and any grammar and spelling errors will be corrected. Ms. Anderson recognized the assistance of City Solicitor Fallon in the process and also recommended to adopt what we have and appoint a subcommittee to go through for policy changes. There was discussion to put the Parks Commission back in. Any Ordinances passed this year will be incorporated with the Revised Ordinances of 2020.

A motion was made by Councillor Camell, seconded by Councillor Crowe, that the Ordinance be recommended favorably. The motion carried by a unanimous vote.
