Councillors asked a wide range of questions regarding city financing, policy and procedures, management style, short and long term investment strategies, diversifying the office, knowledge of city processes, knowledge of tax titles and tax liens, past background in the financial industry and other financial topics. Mr. Grover answered all of the questions stressing his financial acumen and the experience he has gained over the last two years in municipal finance as assistant controller. Mr. Grover also talked about his Malden roots being a life long resident of Malden with his wife and two children. Mr. Grover stressed his commitment to Malden and given his age would be a long term Treasurer for the City.
