Councillor Murphy told the council that the paper needed to be amended because the Salvation Army was approved for \$5,000 and withdrew the request because they will not be running the program this year. The Mayor has suggested the \$5,000 be moved to the Warming Center. Alex Pratt from the MRA was asked to speak on the matter and told the Council that the Warming Center had requested \$22,400 and was approved for \$11,500.

Councillor Murphy said they would have 2 votes, 1 vote for sections 1 (Programs), 3 (Physical Improvements), 4 Planning, Admin & Management), and 5 (Section 108 Loan Repayments) that Councillor Crowe would vote on and then vote on section 2 (Public Services) that Councillor Crowe has been recused.

Councillor Winslow asked about the feasibility study for the rehabilitation of the Linden Park skating rink. Councillor DeMaria asked about the footprint of the rink and if anything would change at the park. Councillor Sica said this is the first year that the rink qualifies for CPC funds and that nothing would change on the footprint at the park. Linden Park would look exactly like it does today but with a rink that could be skated on during the winter months. Councillor Sica informed the Council the feasibility study was paid with her mitigation funds and she will make the report available once completed.
