542-21Order: That the City Council adopt a residential exemption of
30% and a residential factor of 1.75 or 0.901998 for the FY2022
tax rate.

Councillor Murphy moved to suspend council rules to having the public hearing and take up paper 542-21 for discussion on a Committee of the Whole night, the motion was seconded by Councillor Winslow it was so voted 9-1 Camell (y), Condon (y), Crowe (y), Demaria (y), Linehan (y), Murphy (y), O'Malley (n), Sica (y), Winslow (y), Anderson (y).

Assessor Nate Cramer gave a slide presentation on the Fiscal Year 2022 tax classification. The board of Assessors recommended that the 1.75 factor and 30% residential tax exemption be adopted. The 2022 figures are based off of 2019-202 sales. On the residential tax exemption , Mr. Cramer highlighted that a home value of \$977,000 is the limit for the tax exemption and the commercial base does not pick up any of the residential tax exemption. There are 7 single families over the \$977,000 and residential property like Granada Highlands pay a good amount of tax.

Councillor Winslow asked Mr. Cramer why he was recommending staying at 30% when the city could go higher on the exemption,. Mr. Cramer answered that apartment buildings would shift the cost onto the renter creating a financial hardship to the renter.

Councillor DeMaria asked Mr. Cramer to tell the council how he has been able to reduce the number of properties getting the residential exemption. Mr. Cramer said that sales just don't automatically get the exemption and partnering with the Board of Health and Building Department they have been able to identify properties that do not qualify. The number of exemptions are down from 8,604 in 2014 to 8,291.

Council President Anderson opened the public hearing, there were no people that spoke in favor or against the recommended tax classification rate of 1.75 and residential tax exemption of 30%. A motion was made by Councillor Camell, seconded by Councillor DeMaria, that the Order be adopted. The motion carried by a unanimous vote.

Order: That the following position be given special municipal employee status: Person who holds this position works periodically providing assistance to the Inspectional Services Department on an on-call/as-needed basis as a non-benefited, non-regular employee, and must meet one of the following criteria: (1) is not paid; (2) is part-time allowing the person the flexibility to work at another job during normal working hours if the person chooses; or (3) has not been paid by the City of Malden for more than 800 working hours during the preceding 365 days.
