Councillor Spadafora, the sponsor of the paper spoke on the reasons for the paper. Councillor Spadafora was originally going to request that the paper get referred to Public Properties to be discussed but decided after learning Verizon never pulled an electrical permit for the pole from Building Commissioner Miller that he was looking for a vote on the floor. He further stated that it has been a journey with discussions that he had with John Weaver and a Verizon representative with no satisfaction. Councillor Spadafora 's request to move the equipment to another pole, because the equipment was too close to the residents at 37-39 Willard Street. Councillor Spadafora continued that the petition was tabled at the first meeting and when the petition came back months later no notice was sent to the residents at 37-39 Willard Street.

Councillor Camell seconded the motion and thanked Councillor Spadafora for all the work he put into the issue. Councillor Camell said he had spoke against the petition at the first hearing and just lost sight of it because the petitions come in as bunches. Councillor Camell asked the Council to help us correct the error and approve the paper, Councillor Camell said he would not the want the equipment so close to his home either. Councillor Camell requested he get added as a sponsor of the paper.

Councillor Winslow said this is right on the line and Councillor Spadafora had previously asked the antennaes be banned in residential neighborhoods. Legal said we couldn't do that so we went back and rewrote the ordinance. Councillor Winslow asked Asst City Solicitor Mcneil for an opinion.

Assistant City Solicitor McNeil said the information she was hearing in the discussion had not been known to her so she would need to digest the discussion before giving an opinion.

Councillor Murphy spoke in favor of the paper by saying we need to protect our residents.

Councillor Spadafora stated the law is on their side but his request is for them to find a new location for the equipment. Because they did not pull and electrical permit he wants the equipment pulled off the pole.

Councillor O'Malley spoke in favor of the paper.

The resident at 39 Willard Street, Joseph Dauenhauer was allowed to address the council. Mr. Dauenhauer stated he was looking for compassion from the council and his family feels unsafe because of the closeness of the antennae to his daughter's bedroom.
